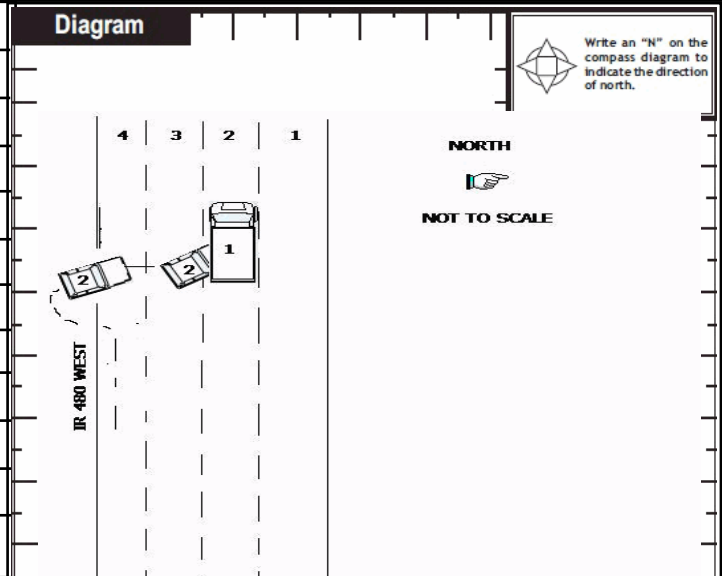




UNIT #1 AND #2 WERE TRAVELLING W/B ON IR 480. THE DRIVER OF UNIT #1 STATED HE WAS DRIVING IN LANE #4. THE DRIVER OF UNIT #2 WAS DRIVING IN LANE #2. THE DRIVER OF UNIT #1 STATED 2 VEHICLES CUT IN FRONT OF HIS VEHICLE. UNIT #1 THEN LOST CONTROL WHEN HE SLAMMED ON THE BRAKES FISH TAILING LEFT OFF OF THE ROADWAY. THE VEHICLE THEN DID A 180 DEGREE TURN, WENT BACK ON THE ROADWAY, AND STRUCK UNIT #2.
