


UNIT #2 WAS TRAVELING E/B ON MCCRACKEN. UNIT #1 WAS TRAVELING W/B ON MCCRACKEN, THEN ATTEMPTING TO MAKE A S/B TURN ONTO TURNEY ROAD. WHEN ENTERING THE INTERSECTION, UNIT #1 DID NOT SEE UNIT #2 CLEAR THE INTERSECTION, CAUSING IT TO TURN TOO SOON AFTER UNIT#2. THIS RESULTED IN UNIT #1'S FRONT DRIVER'S-SIDE TO COME IN CONTACT WITH THE REAR DRIVER'S-SIDE OF UNIT #2.
