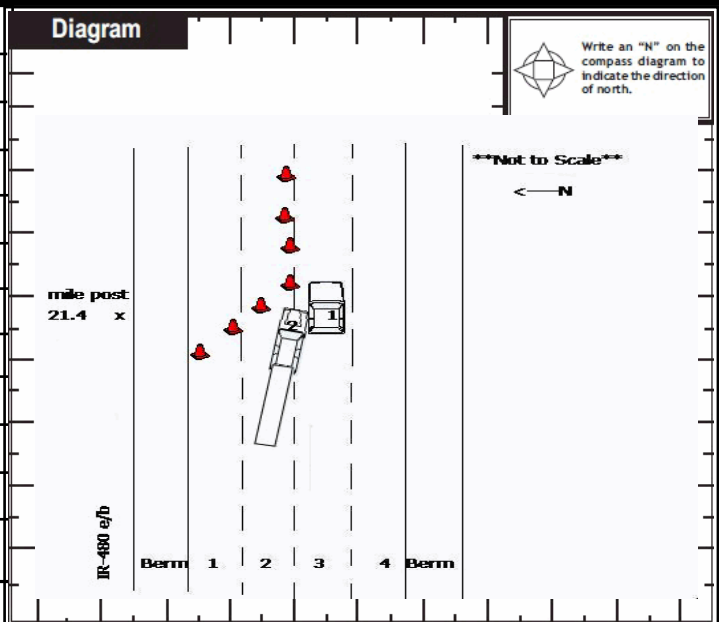

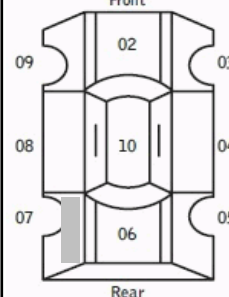

LANE #1 WAS BLOCKED OFF FOR CONSTRUCTION AHEAD ON IR-480 E/B AT MILE POST 21.4. DRIVER OF UNIT #2 WAS TRAVELLING IN HEAVY TRAFFIC IN LANE #2 AND NOTICED THAT LANE WAS ALSO BEING CLOSED FOR CONSTRUCTION AHEAD. THE DRIVER OF UNIT #2 ATTEMPTED TO CHANGE LANES INTO LANE #3 AND STRUCK UNIT #1. DRIVER OF UNIT #1 STATED SHE WAS TRAVELLING IN HEAVY TRAFFIC IN LANE #3 AND APPROACHING WORKERS AT THE TRANSPORTATION BLVD BRIDGE WHEN UNIT #2 CAME INTO HER LANE AND HER VEHICLE WAS STRUCK.
