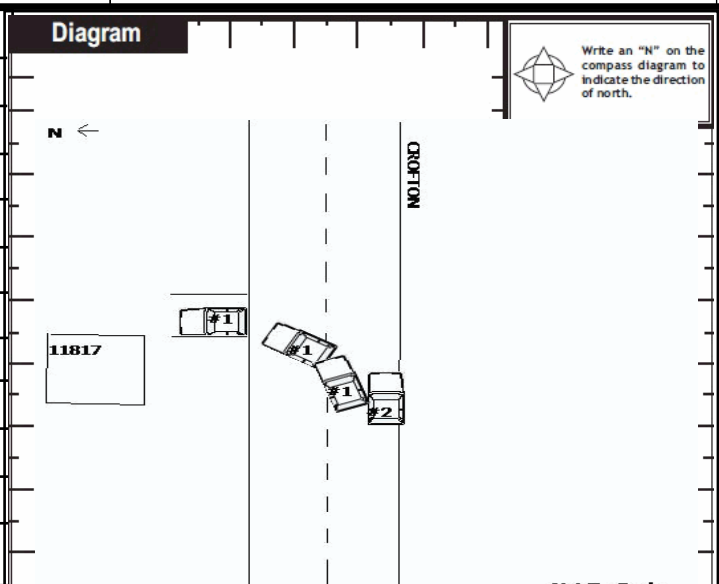

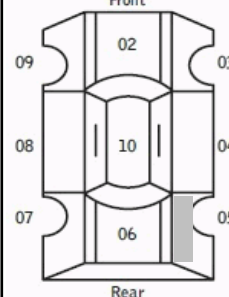



THE DRIVER OF UNIT #1 STATED THAT SHE WAS NOT PAYING ATTENTION WHEN SHE BACKED OUT OF THE DRIVEWAY BEFORE STRIKING UNIT #2.
