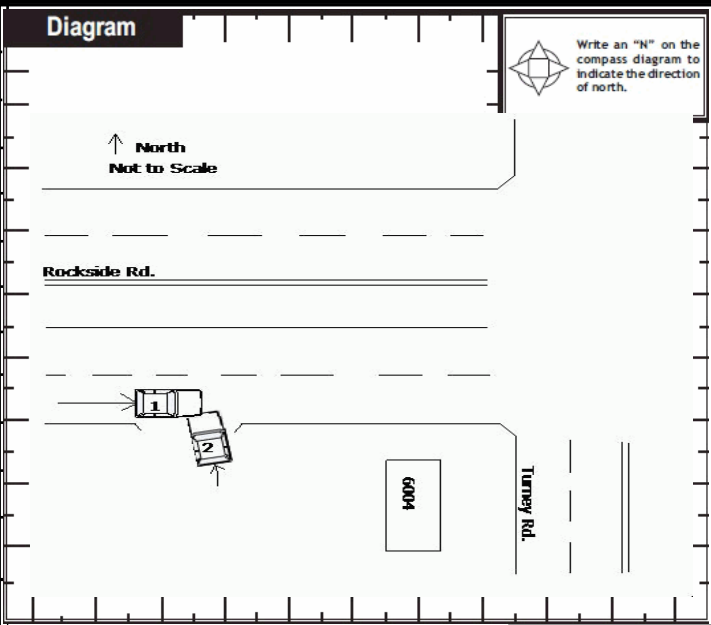

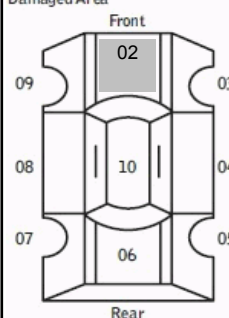


UNIT 1 WAS TRAVELING EAST ON ROCKSIDE RD. APPROACHING THE SIDE EXIT OF 6004 TURNEY RD. UNIT 2 WAS EXITING THE SIDE DRIVE OF 6004 TURNEY RD. TO TURN LEFT ONTO ROCKSIDE. WHEN THE DRIVER OF UNIT 1 SAW UNIT 2 APPROACHING THE EXIT, HE THOUGHT UNIT 2 WAS GOING TO DRIVE INTO HIS PATH SO HE SIGNALLED THAT HE WOULD TURN RIGHT INTO THE DRIVEWAY 6004 TURNEY. DRIVER OF UNIT 2 STOPPED FOR UNIT 1 BUT THEN SAW THE TURN SIGNAL AND PROCEEDED INTO THE ROADWAY. WHEN UNIT 2 STOPPED, THE DRIVER 1 CANCELLED THE TURN SIGNAL AND PROCEEDED STRAIGHT. UNIT 1 STRUCK UNIT 2
