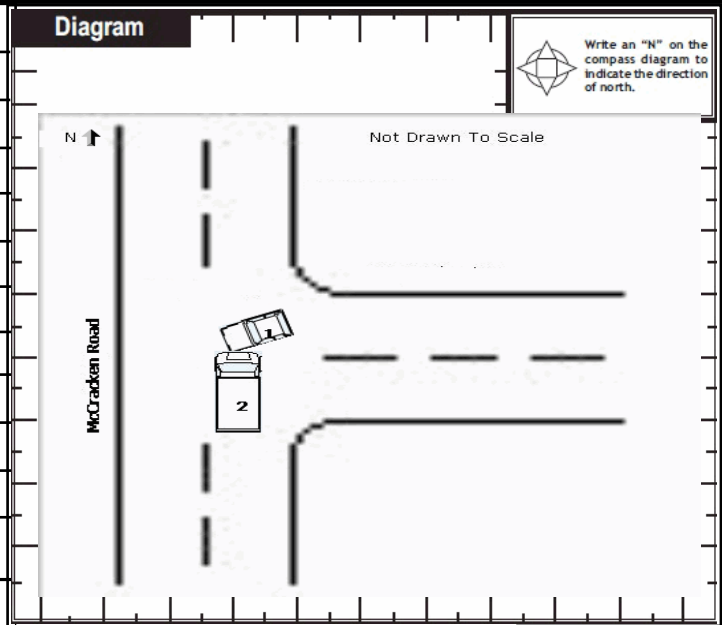


Narrative

UNIT #1 DID NOT YIELD TO UNIT #2 AS IT TURNED, CASUING IT TO BE STRUCK IN THE FRONT DRIVER'S-SIDE, WITH THE FRONT-END OF UNIT #2.
