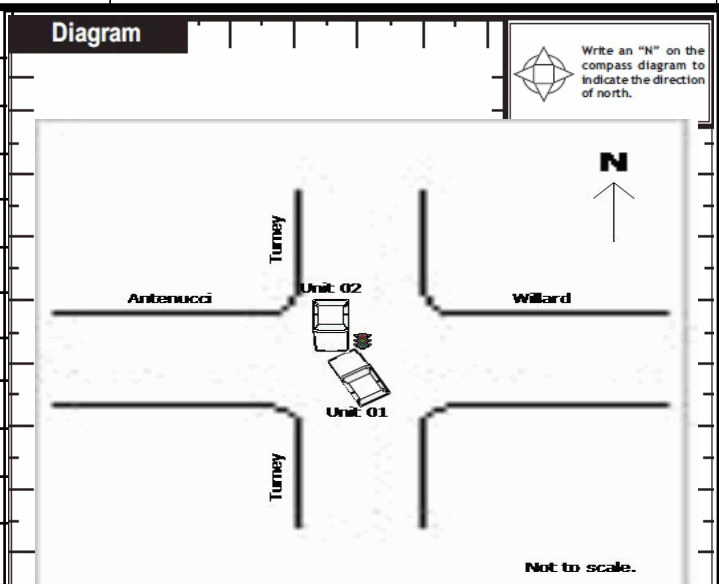

UNIT 02 WAS TRAVELING SOUTH ON TURNEY RD AT ANTENUCCI BLVD AND ENTERED THE INTERSECTION AFTER THE TRAFFIC LIGHT HAD ALREADY CHANGED TO RED. THE FRONT LEFT OF UNIT 02 THEN STRUCK THE FRONT CENTER OF UNIT 01.


