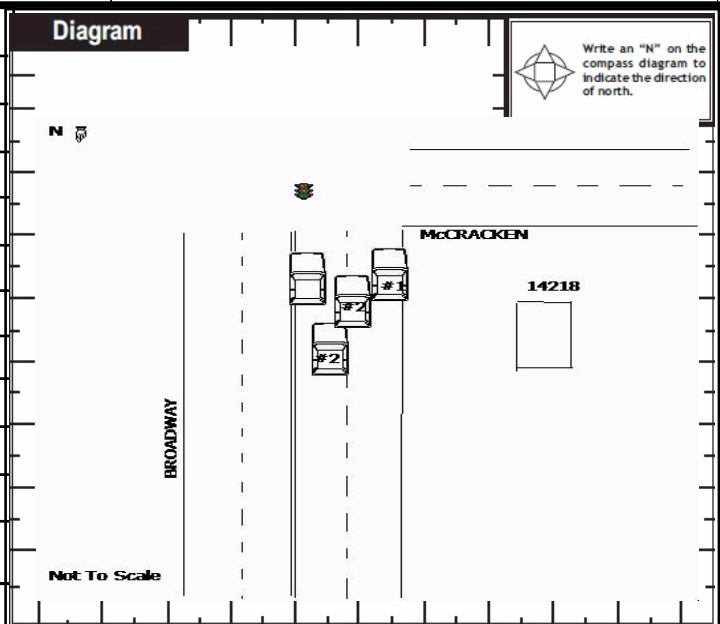

UNIT #1 WAS TRAVELING SOUTHBOUND ON BROADWAY AVE. AND WAS STOPPED AT THE TRAFFIC LIGHT AT BROADWAY AND MCCRACKEN. UNIT #2 WAS TRAVELING SOUTH ON BROADWAY AND WHILE APPROACHING THE LIGHT UNIT #2 WAS TRYING TO STOP AND IN FEAR OF HITTING THE VEHICLE IN FRONT OF HER. THE DRIVER BRIANNA VEERED TOWARDS THE RIGHT LANE TRYING TO FIT IN BETWEEN THE VEHICLES IN FRONT OF HER AND STRUCK UNIT #1'S LEFT SIDE WITH UNIT #2'S RIGHT SIDE. UNIT #1 WAS IN THE RIGHT LANE NEAR THE CURB AND UNIT #2 WAS IN THE LEFT LANE.
