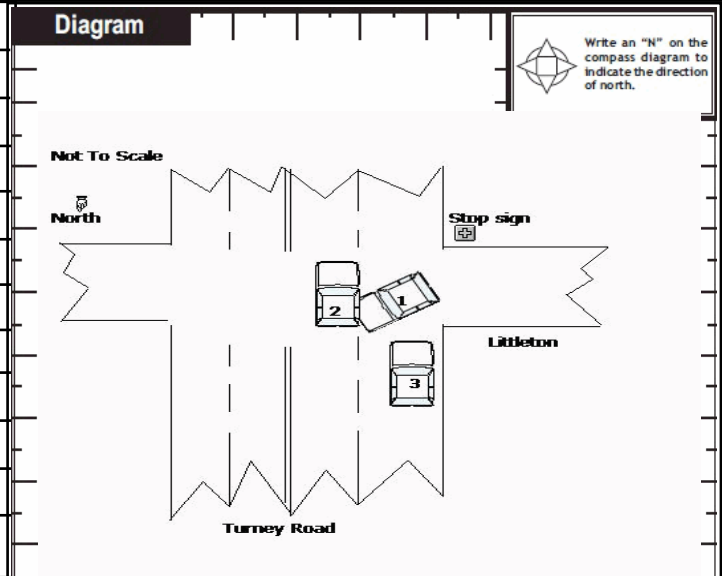

 UNIT #1 WAS ATTEMPTING TO TURN LEFT FROM LITTLETON AFTER LEAVING A STOP SIGN, AND TRAVEL NORTH ON TURNEY RD. UNIT #2 WAS TRAVELING SOUTH ON TURNEY IN THE INSIDE LANE AT LITTLETON. UNIT #3, A NON CONTACT UNKNOWN VEHICLE, WAS TRAVELING SOUTH ON TURNEY IN THE OUTSIDE LANE AND WAS STOPPED AT LITTLETON. UNIT #1 FAILED TO OBEY THE STOP SIGN. AS A RESULT, THE RIGHT FRONT OF UNIT #1 COLLIDED WITH THE RIGHT REAR SIDE OF UNIT #2. BOTH UNITS WERE AT FINAL REST UPON ARRIVAL. UNIT #3 LEFT THE SCENE.
