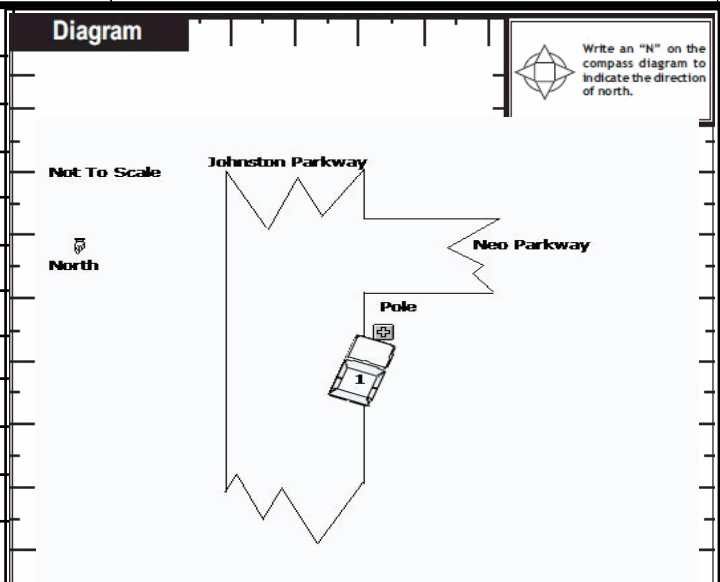

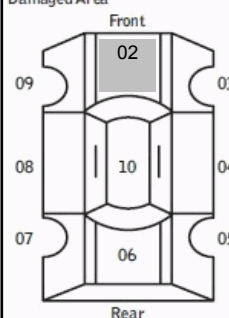
Narrative

UNIT #1 WAS TRAVELING SOUTH ON JOHNSTON PARKWAY APPROACHING NEO PARKWAY. FOR UNKNOWN REASON, UNIT #1 LOST CONTROL. AS A RESULT, UNIT #1 TRAVELED OFF THE WEST SIDE OF THE ROADWAY AND THE FRONT COLLIDED WITH A LIGHT POLE. UNIT #1 WAS MOVED FROM FINAL REST AND LOCATED ON MCCracken Rd FACING EAST, NEAR THE INTERSECTION OF JOHNSTON PARKWAY.
