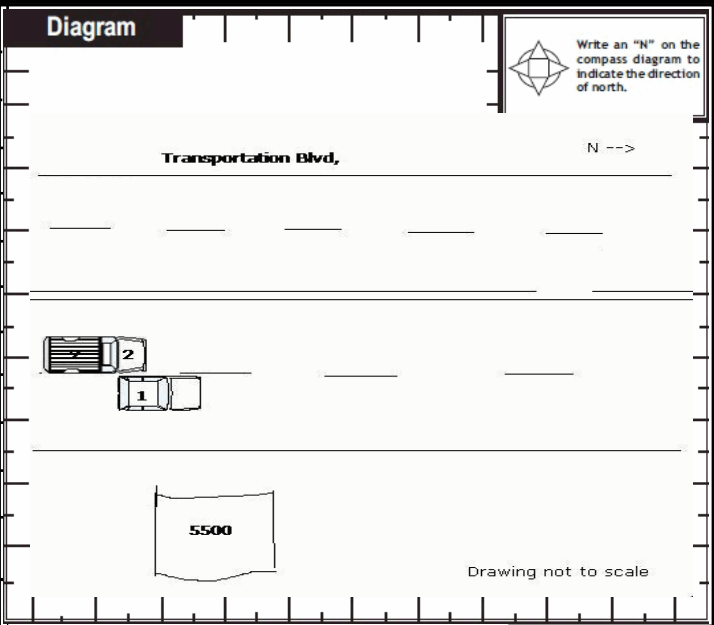




Narrative
 UNIT #1 WAS TRAVELING NORTH BOUND ON TRANSPOTATION BLVD. IN THE CURB LANE. UNIT #2 WAS TRAVELING IN THE SAME DIRECTION IN THE MIDDLE LANE SILGHTLY TO THE REAR OF UNIT #1. THE DRIVER OF UNIT #1 STATED THE DRIVER OF UNIT #2, DRIFTED OVER INTO HER LANE CAUSING IT'S FRONT PASSENGER TIRE TO MAKE CONTACT WITH HER DRIVER SIDE REAR FENDER. THE DRIVER OF UNIT #2 STATED THE DRIVER OF UNIT #1 WHILE ON HER CELL PHONE DRIFTED INTO HIS LANE CAUSING HER DRIVERS SIDE REAR FENDER TO MAKE CONTACT WITH HIS FRONT PASSENGER SIDE TIRE CAUSING NO DAMAGE.
