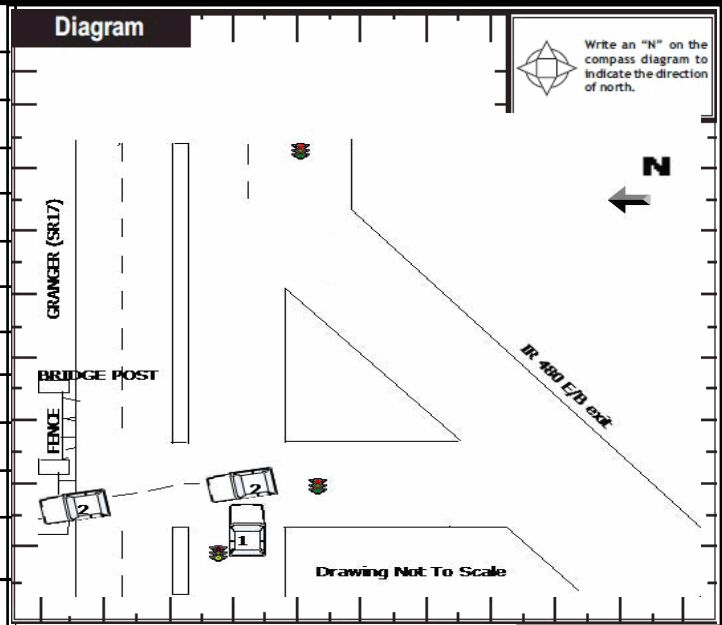

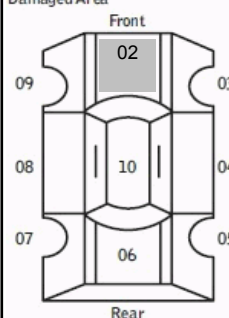



THE DRIVER OF UNIT #1 STATED HIS LIGHT WAS GREEN AND UNIT #2 PULLED INTO THE INTERSECTION TO TURN LEFT. UNIT #1 STRUCK UNIT #2. THE DRIVER OF UNIT #2 STATED HE HAD A GREEN LIGHT AND WAS TURNING LEFT ON TO GRANGER WHEN UNIT #1 WENT THROUGH A RED LIGHT AND STRUCK UNIT #2.
