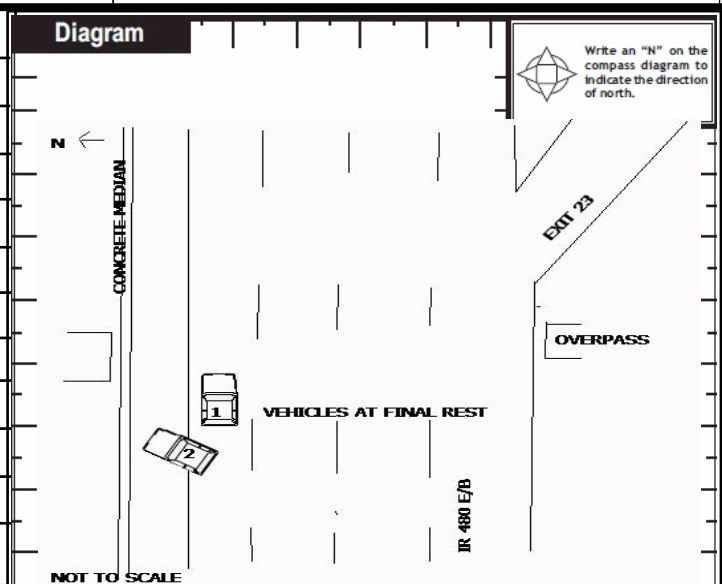

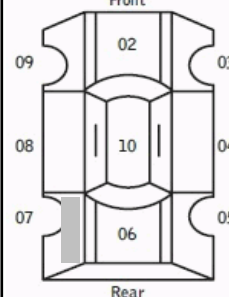



 UNIT 1 WAS E/B ON IR480 AT SR 14 (EXIT 23) IN THE LEFT LANE. UNIT 2, A MARKED CLEVELAND POLICE VEHICLE, WITH LIGHTS AND SIREN ACTIVATED WAS ACTIVELY PURSUING A VEHICLE. UNIT 2 WAS ALSO IN THE LEFT LANE. THE PURSUED VEHICLE BEGAN TRAVELLING IN THE LEFT SHOULDER. UNIT 1 WAS SLOWED IN TRAFFIC AND WAS UNABLE TO YIELD TO UNIT 2 AND MOVE TO THE RIGHT WHEN UNIT 2 WAS UNABLE TO STOP IN TIME AND STRUCK UNIT 1 IN THE REAR.
