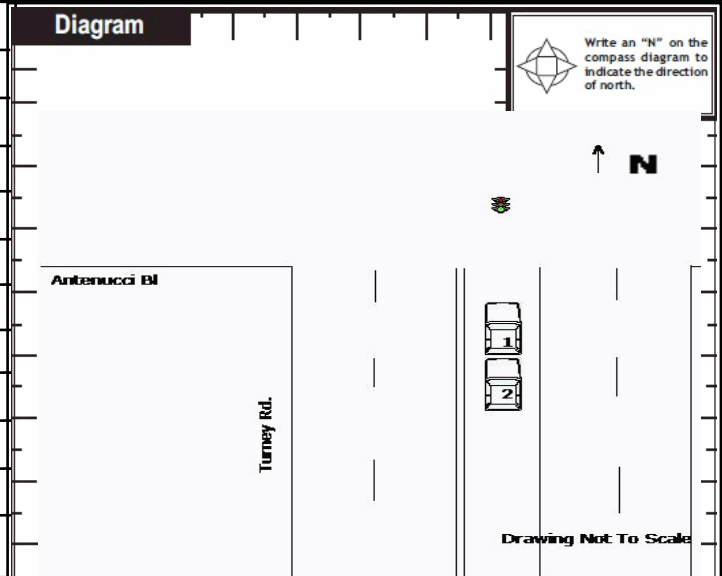

UNIT 2 WAS STOPPED IN TRAFFIC DIRECTLY BEHIND UNIT 1. TRAFFIC BEGAN TO MOVE AND THEN CAME TO A STOP AGAIN. DRIVER OF UNIT 2 STATES HER COFFEE CUP LID CAME OFF AND DREW HER ATTENTION FROM THE ROAD AND SHE COULD NOT REACT IN TIME TO AVOID STRIKING UNIT 1.

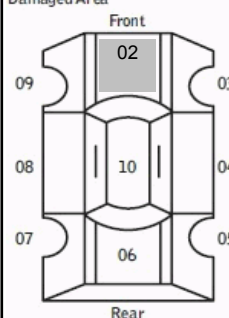

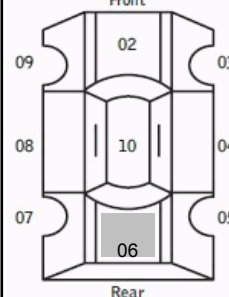
