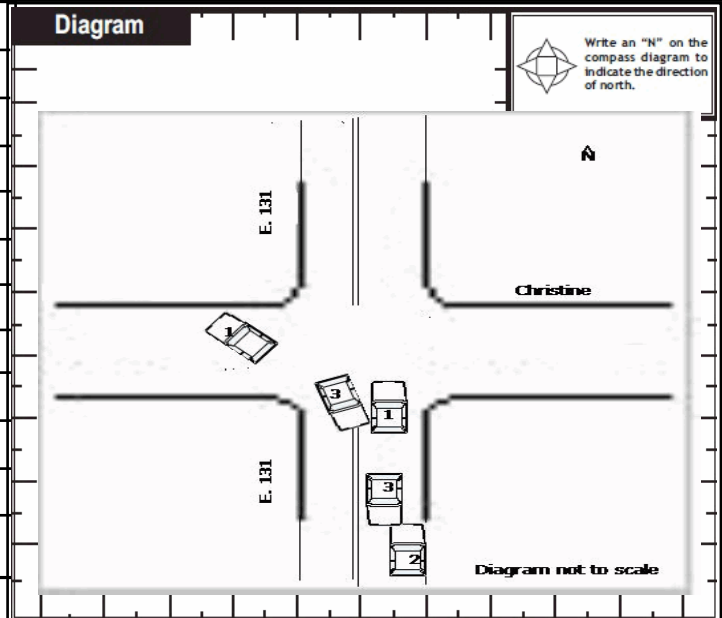





DRIVER OF UNIT 1 STATES SHE WAS TRAVELING N/B ON E. 131 APPROACHING CHRISTINE AVE. WHEN SHE OBSERVED UNIT 3 (SOUTHBOUND) CROSS OVER THE CENTER LINE AND ENTER HER LANE. SHE ATTEMPTED TO AVOID A COLLISION HOWEVER UNIT 3 CONTINUED TOWARD HER AND STRUCK UNIT 1. AFTER STRIKING UNIT 1, UNIT 3 CONTINUED S/B AND STRUCK UNIT 2 THAT WAS PARKED, UNOCCUPIED ALONG THE EAST CURB OF E. 131 IN FRONT OF 4501. DRIVER OF UNIT 3 WAS UNABLE TO GIVE AN ACCOUNT OF THE INCIDENT DUE TO INTOXICATION AT THE TIME OF THE MVA.


