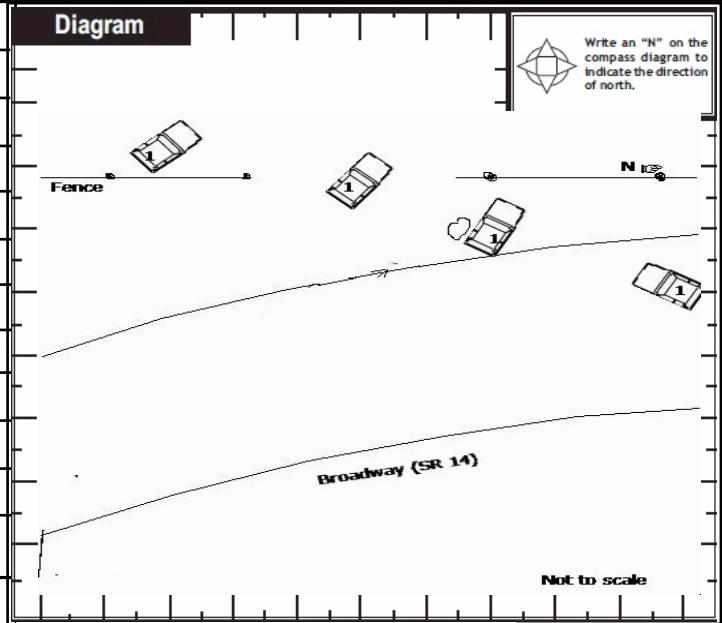

UNIT 1 WAS TRAVELLING S/E ON SR 14 (BROADWAY) WHEN IT APPEARS TO HAVE LOST CONTROL AS IT PASSED THE LOT OF 11321 BROADWAY. FROM THE MARKS LEFT ON THE ROADWAY AND SIDEWALK ON THE WEST SIDE OF THE STREET, IT APPEARED UNIT UNIT WAS TRAVELING AT A HIGH RATE OF SPEED, DROVE OFF OF THE ROADWAY AS IT SLID SIDWAYS. AFTER DRIVING SKIDING OVER THE SIDEWALK, THE DRIVER SIDE REAR OF THE VEHICLE STRUCK A TREE, SENDING IT TOWARD A WOODEN FENCE. UNIT 1 CONTINUED TO SKID AND STRUCK THE WOODEN FENCE CAUSING IT TO BREAK.

<p>I was met on scene by Cleveland Metro Park Rangers whom advised that a Kim Sanducci had observed the damaged vehicle off the roadway . While she was speaking with dispatcher, Sanducci observed a w/f and w/m pull up in a blue Chevy (GBY8925) near the wrecked vehicle. The male exited the vehicle and removed some items from the front seat and as he was returning to his vehicle he began yelling at Sanducci to "not say a fucking word". I was then advised by Ranger that the male had checked into Marymount ER and had been examined for possible injuries. Ptl. Baon responded to the ER and was advised that the male had checked out. While on scene, Ptl. Baon was advised by Cleveland Clinic Officer Kontura that he had spoken with the male and he was identified by Kontura as Jacob Lane. Lane advised Kontura that he had been driving his vehicle, a blue Ford Taurus (GRP6582) and lost control of the vehicle and had been in an MVA but he believed that the MVA had occurred in Cleveland. Ptl. Baon was also advised by a ER nurse, Sandra Fryofsky, that she had treated Lane and while doing so was told by Lanes girlfriend, Julie Debrose, the following. She and Lane had been at her house drinking all night. Lane became extremely intoxicated and wanted to leave her home to drive home. She and Lane argued about him leaving and he eventually left. Debrose got into her car and followed behind Lane. As he drove onto Broadway in Garfield Hts he began to accelerate and as he attempted to negotiate a curve in the roadway, lost control of the vehicle and went off of the roadway and struck several items. After his vehicle came to a rest, he exited and entered her vehicle and she then transported him to Marymount ER. During the MVA unit 1 damaged a large section of wooden fence and 1 gas grill, both items are property of the Cleveland Metro Parks, 4101 Fulton Pkwy, Cleveland OH, 216-635-3200</p>
