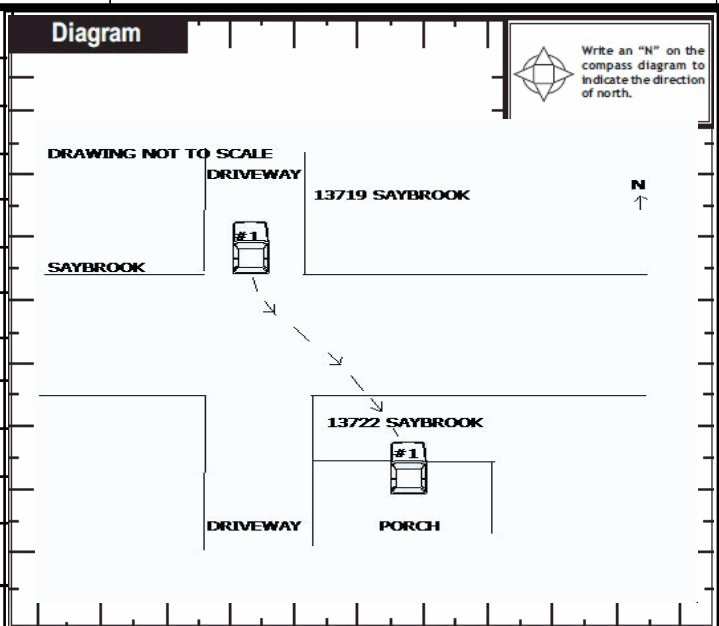


Narrative
