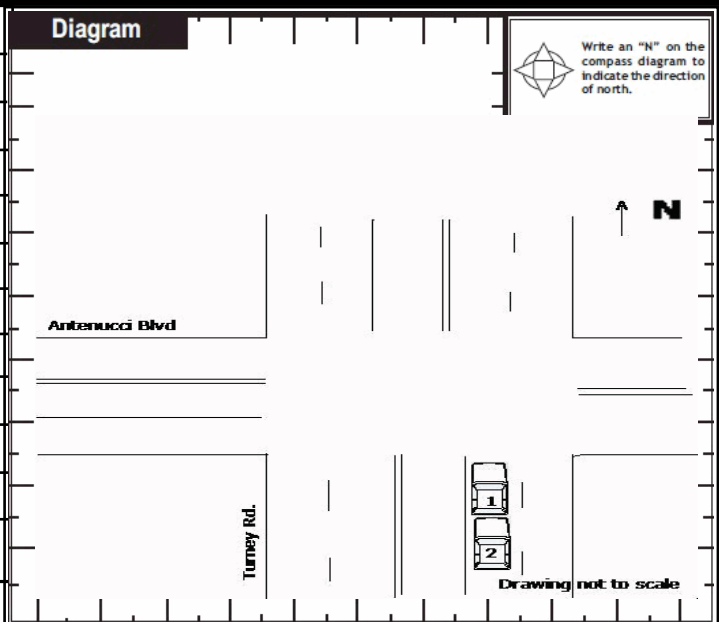

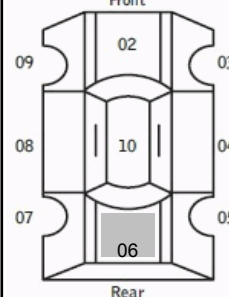

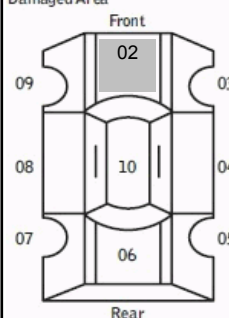

 UNIT 1 WAS STOPPED AT A RED LIGHT, IN THE LEFT LANE, NORTHBOUND ON TURNEY RD. AT ANTENUCCI BL. UNIT 2 WAS TRAVELING NORTHBOUND IN THE LEFT LANE ON TURNEY RD. APPROACHING ANTENUCCI BL. DRIVER OF UNIT 2 STATED HE LOOKED AWAY AS HE WAS APPROACHING THE LIGHT AND WHEN HE LOOKED BACK, HE OBSERVED UNIT 1 AND STRUCK UNIT 1, UNABLE TO STOP IN TIME TO AVOID COLLISION.
