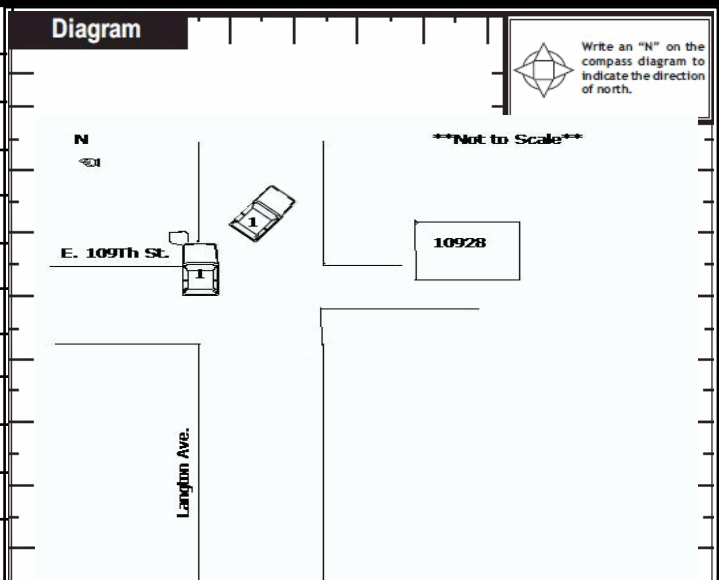

<p>Officer Lee #007 along with Officer Sabelli #42, was dispatched to the area of Langton Ave and E 109Th St. for a car in the middle of the roadway unattendant. Upon our arrival, we noticed a silver Chevy Impala in the middle of the roadway. The vehicle struck a pole causing disabling damage to the front driver side fender and tire coming to rest in the middle of the street. While on scene, dispatch advised us that the driver was at Marymount ER. Sgt. Merchant arrived on scene to assist and at that time, myself and Officer Sabelli, responded to Marymount ER, to speak with the driver. Upon our arrival, the ER staff advised us that the female driver was in room #12. Upon our arrival, at room#12, I observed a black female laying on the ER bed crying with a cervical collar on and her right arm bandage up. The female was identified as Sharonda D. George. Sharonda stated she was traveling east bound on Langton Ave. approaching E 109Th St. when she attempted to apply the brakes to slow the vehicle down. Sharonda stated the brake pedal went to the floor and at that time she panic and she struck a pole that was on the curb. Sharonda stated at that time she called her girlfriend to come pick her up and take her to the hospital in which she did.</p>
