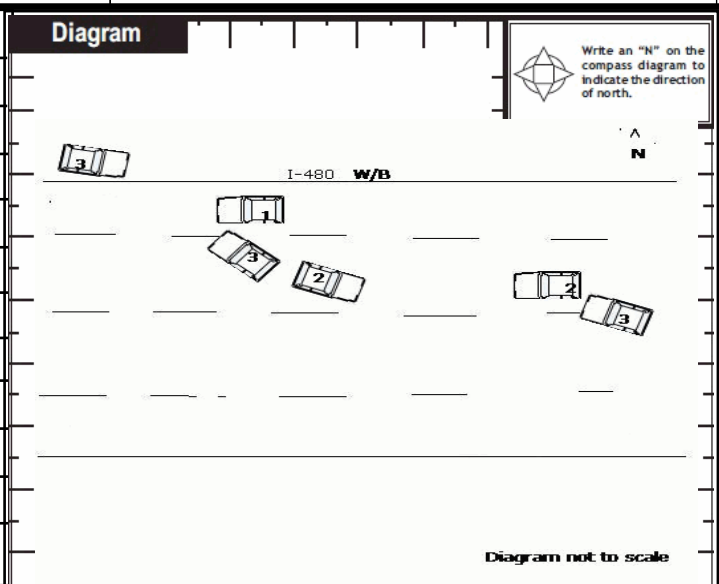




**Narrative**  
 DRIVER OF UNIT 1 STATES HE WAS TRAVELING W/B ON 480 AND WAS STRUCK BY UNIT 3, AFTER BEING STRUCK, UNIT THREE CONTINUED OUT OF CONTROL BEFORE COMING TO A FINAL REST IN THE GRASS OFF THE NORTH SIDE OF THE FREEWAY. DRIVER OF UNIT 1 EXITED HIS VEHICLE TO CHECK ON THE DRIVER OF UNIT 3 AND THE DRIVER OF UNIT 3 ADVISED HE WAS FINE. A SHORT TIME LATER, THE DRIVER OF UNIT 3, DESCRIBED AS A B/M WITH SHOULDER LENGTH HAIR HAD FLED THE SCENE IN AN UNKNOWN DIRECTION.  
 DRIVER OF UNIT 2 STATES SHE WAS TRAVELING W/B ON 480 AND WAS STRUCK BY UNIT 3.
