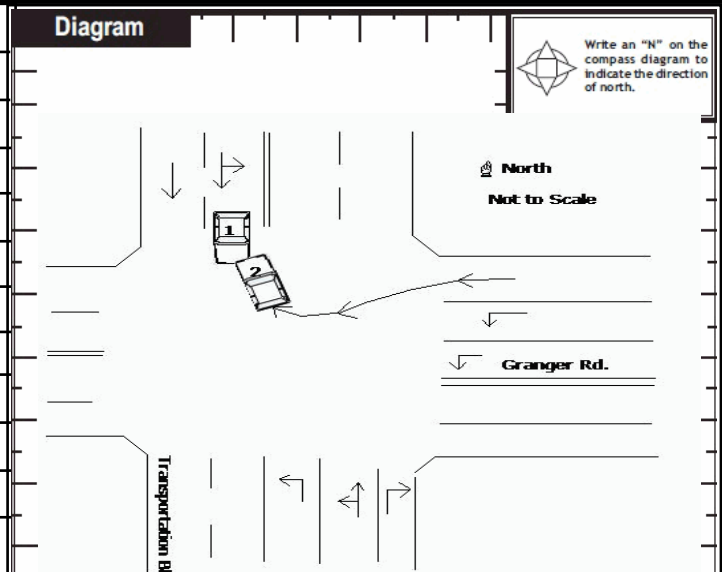

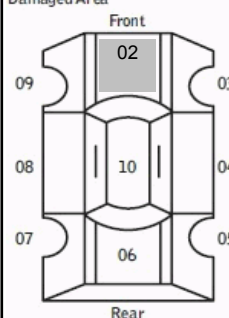


UNIT 1 WAS STOPPED WAS STOPPED ON TRANSPORTATION BL. FOR A RED LIGHT AT GRANGER RD. IN THE CENTER LANE FACING SOUTH. UNIT 2 WAS TRAVELING WEST ON GRANGER RD. APPROACHING TRANSPORTATION BL. IN THE CURB LANE TO PROCEED STRAIGHT. THE TRAFFIC LIGHT FOR UNIT 2 WAS RED AND UNIT 2 ATTEMPTED TO STOP. UNIT 2 SLID ON A SNOW COVERED ROAD WAY AND LOST CONTROL. UNIT 2 ENTERED THE INTERSECTION, DRIFTED TO THE RIGHT AND STRUCK UNIT 1.
