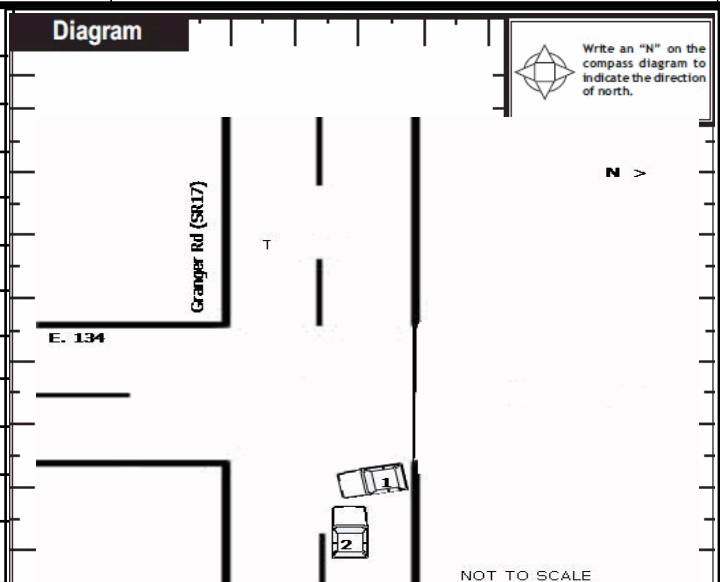





DRIVER OF UNIT 1 STATES SHE WAS TRAVELING W/B ON SR17 AND A VEHICLE STOPPED ABRUPTLY IN FRONT OF HER. SHE STOPPED TO AVOID THE VEHICLE IN FRONT OF HER AND SLID SIDWAYS FACING S/B IN THE W/B LANE. UNIT 2, UNABLE TO STOP DUE TO THE ROAD CONDITIONS SLID INTO THE FRONT LEFT SIDE OF UNIT 1. DRIVER OF UNIT 2 STATES HE WAS TRAVELING W/B ON SR17, UNIT 1 STOPPED ABRUPTLY, SLID SIDWAYS AND UNIT 2 STRUCK UNIT 1 WHILE ATTEMPTING TO STOP.
