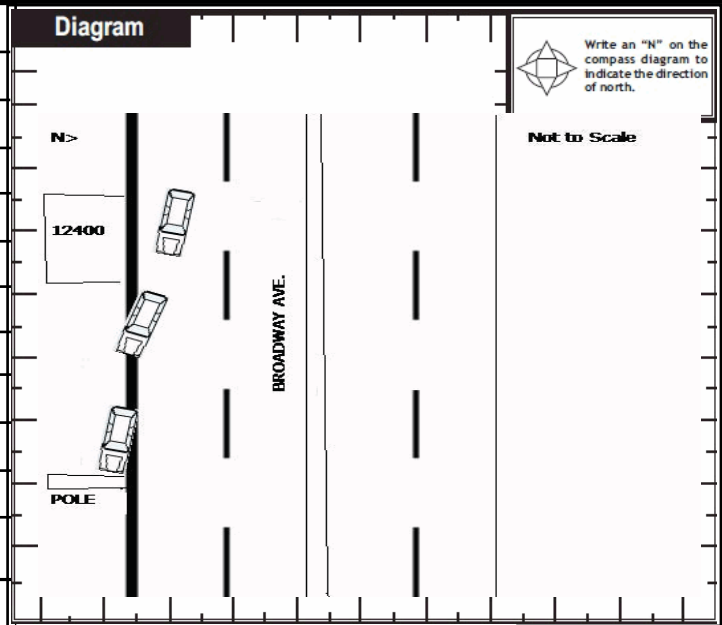

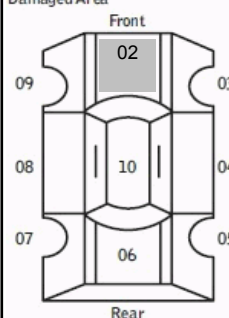
Narrative

<p>AFTER THE CRASH, THE DRIVER AND ANY OCCUPANTS OF UNIT 1 FLED THE AREA. WITNESSES WHO REPORTED THE CRASH TO DISPATCH ADVISED THAT TWO BLACK MALES AND ONE WHITE FEMALE WERE STANDING OUTSIDE THE CAR RIGHT AFTER THE CRASH. THE OWNER OF UNIT 1 ARRIVED ON SCENE. SHE STATED THAT SHE WAS ASLEEP AND AWOKE TO NOTICE HER VEHICLE MISSING FROM 5056 CATO DRIVE IN MAPLE HTS. SHE CLAIMS SHE THEN CALLED MAPLE HTS PD TO REPORT THE THEFT BEFORE DRIVING AROUND HERSELF TO LOOK FOR THE VEHICLE. THERE WAS NO DAMAGE TO THE IGNITION OR COLUMN MAKING IT LIKELY THAT WHOEVER HAD POSSESSION OF THE CAR ALSO HAD KEYS TO THE VEHICLE. THE OWNER OF THE VEHICLE DID NOT MATCH THE DESCRIPTION GIVEN BY WITNESSES OF THE PARTIES AROUND THE CAR AFTER THE CRASH. HOWEVER, ALSO ON SCENE WAS THE OWNER'S WIFE. INSIDE THE VEHICLE OFFICERS FOUND A PURSE WITH MONEY STILL INSIDE, ALONG WITH CREDIT AND BANK CARDS BELONGING TO ALYSSA JORDAN (THE WIFE). ALYSSA DID NOT HAVE ANY INJURIES AND WAS ADAMENT THAT SHE WAS NOT IN THE CAR THIS EVENING. SHE STATED HER PERSONAL BELONGINGS ARE IN THE VEHICLE BECAUSE EVEN THOUGH THE CAR IS REGISTERED TO HER WIFE SHAYLA JORDAN, SHE IN FACT IS THE ONE WHO DRIVES THE CAR AND USES IT AS HER OWN.</p>
