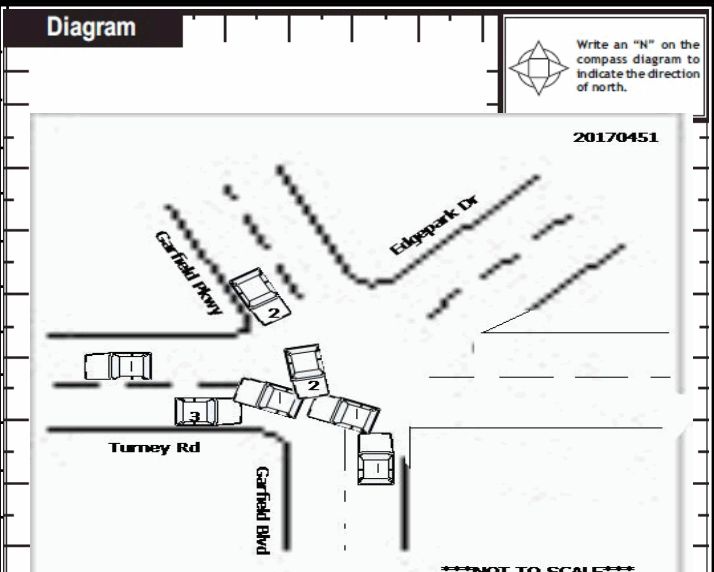

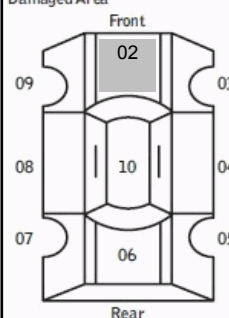

WHEN THE LIGHT TURNED GREEN FOR UNIT 2 HE PROCEEDED STRAIGHT TO GARFIELD BLVD AT WHICH TIME UNIT 1 FAILED TO YIELD AND TURNED LEFT IN FRONT OF UNIT 2 CAUSING UNIT 2 TO STRIKE UNIT 1. UNIT 1 THEN CONTINUED N/B ON TURNEY RD INTO UNIT 3 THEN FLED THE AREA.
