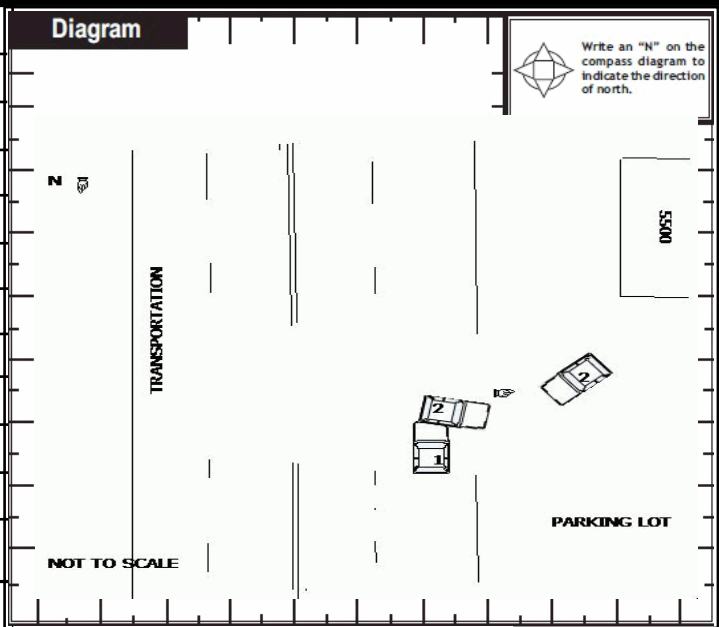

UNIT 1 WAS S/B ON TRANSPORTATION IN CURB LANE.


