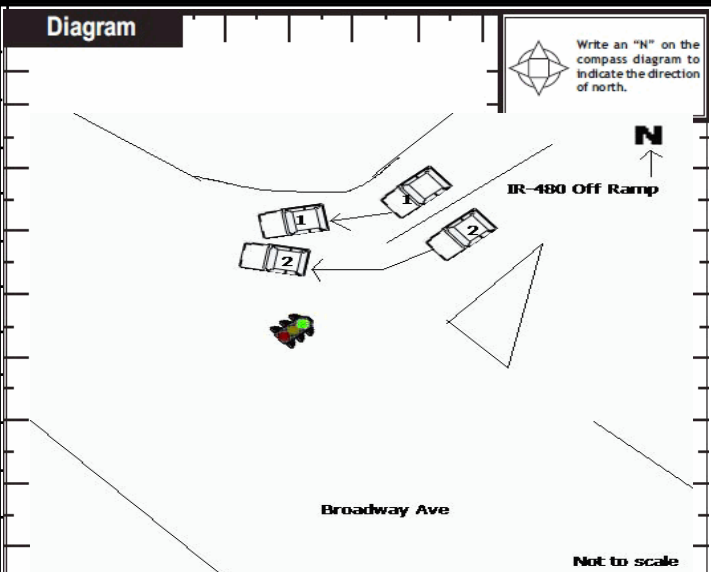

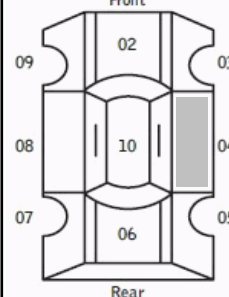


Narrative
