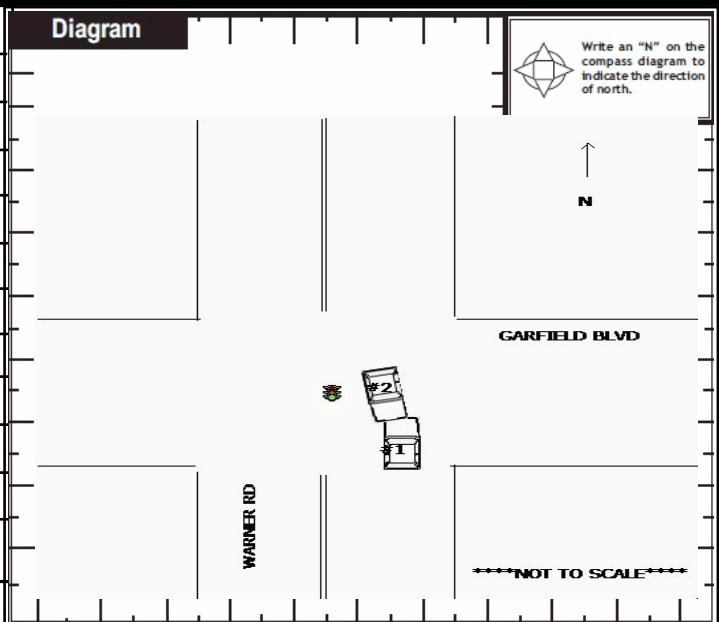

UNIT #1 WAS N/B ON WARNER RD IN THE RIGHT LANE.

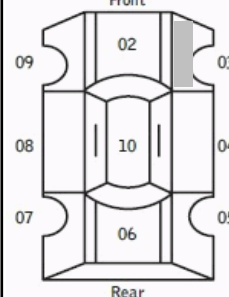
