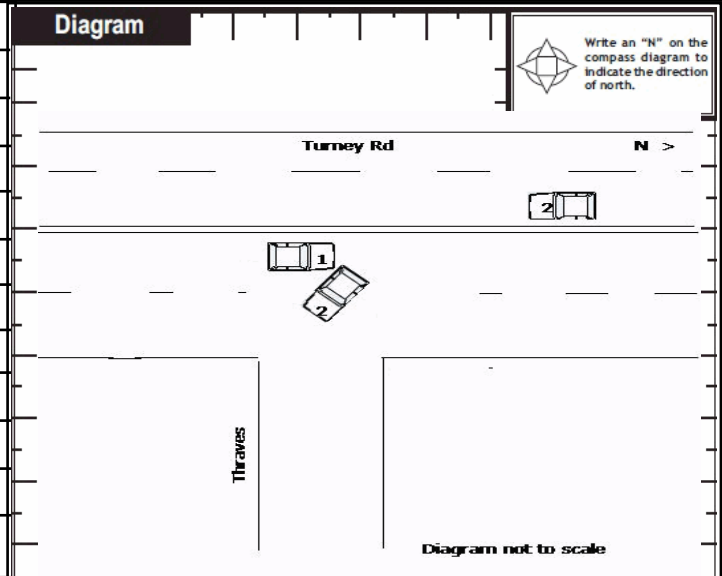

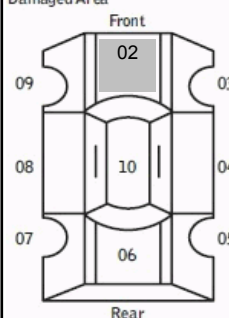

DRIVER OF UNIT 1 STATES SHE WAS TRAVELING N/B ON TURNEY RD AND UNIT 2 FAILED TO YIELD TO UNIT 1 WHILE ATTEMPTED TO TURN LEFT (E/B) ONTO THRAVES AND UNIT 1 STRUCK UNIT 2. DRIVER OF UNIT 2 STATES SHE WAS ATTEMPTING TO TURN E/B ONTO THRAVES AND MISJUDGED THE DISTANCE BETWEEN THE TWO VEHICLES CAUSING UNIT 1 TO STRIKE UNIT 2. WITNESS TO THE MVA STATED THAT UNIT 2 FAILED TO YIELD TO UNIT 1 AND ATTEMPTED TO TURN ONTO THRAVES AND WAS STRUCK BY UNIT 1.
