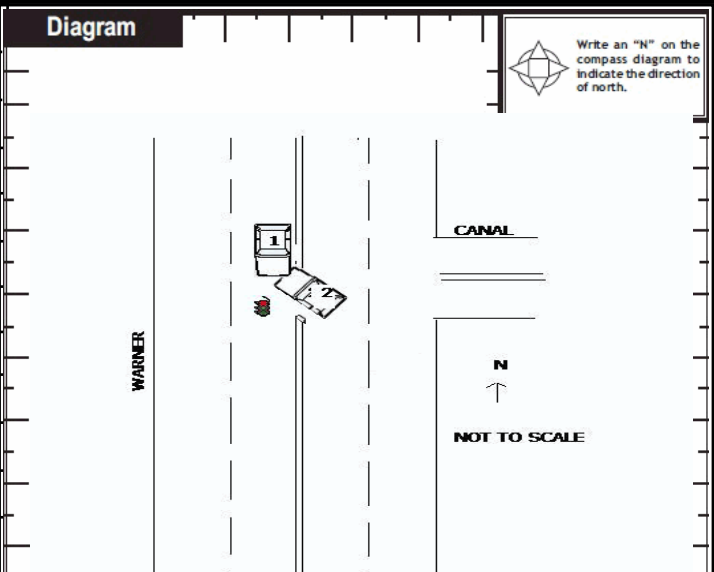





UNIT #2 WAS TRAVELLING W/B ON CANAL AND BEGAN TO TURN RIGHT (N/B) ON TO WARNER. UNIT #2 WENT LEFT OF CENTER AND STRUCK UNIT #1. THE DRIVER OF UNIT #1 GOT OUT OF THE VEHICLE TO CHECK THE DAMAGE AND THE DRIVER OF UNIT #2 ALMOST STRUCK THE DRIVER OF UNIT #1. UNIT #2 FLED N/B DOWN WARNER.
