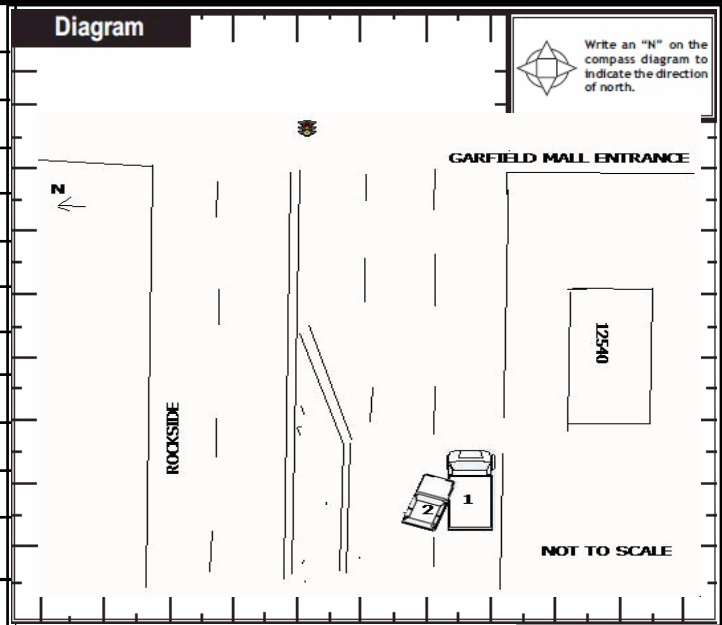

UNIT 1 STATES THAT SHE WAS E/B ON ROCKSIDE IN THE CURB LANE WHEN UNIT 2, WHICH WAS IN THE SECOND LANE, ATTEMPTED TO CHANGE LANES INTO THE CURB LANE. UNIT 2 ENTERED INTO UNIT 1'S CURB LANE AND UNIT 1 THEN STRUCK UNIT 2 ON THE PASSENGER SIDE FRONT. THE IMPACT POINT WAS JUST BEHIND UNIT 1 FRONT TIRE, AT THE SIDE FUEL TANK.


UNIT 2 STATES THAT SHE WAS IN THE SECOND LANE AND SHE BEGAN TO EDGE INTO THE CURB LANE, INFRONT OF UNIT 1. UNIT 2 STATED THAT SINCE SHE HAD HER TURN SIGNAL ON AND SHE WAS JUST AHEAD OF UNIT 1, SHE CAN ENTER THE LANE. UNIT 2 THEN ENTERED THE CURB
