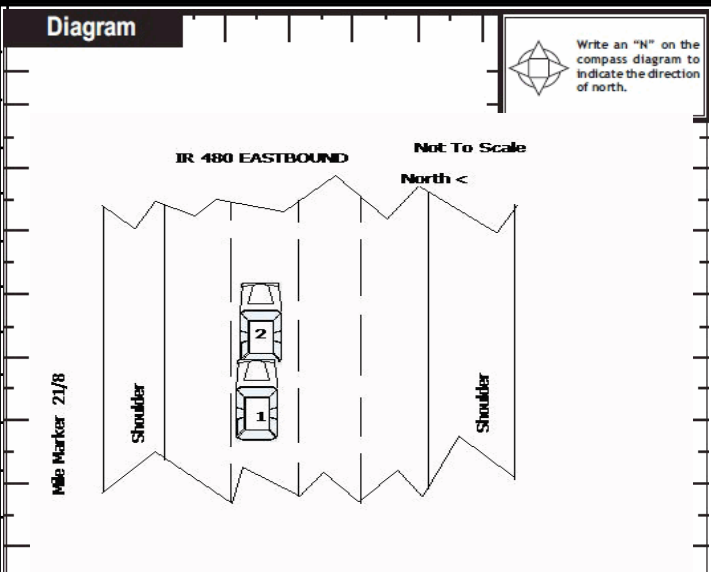

UNIT #1 WAS TRAVELING EAST ON IR 480 NEAR MILE MARKER 21/8 IN THE MIDDLE OUTSIDE LANE DIRECTLY BEHIND UNIT #2. UNIT #2 WAS SLOWING FOR TRAFFIC. UNIT# 1 FAILED TO MAINTAIN ASSURED CLEAR DISTANCE AHEAD. AS A RESULT, THE FRONT ON UNIT #1 COLLIDED WITH THE REAR OF UNIT #2. BOTH UNITS WERE MOVED FROM FINAL REST AND WERE PARKED ON THE NORTH SHOULDER OF EASTBOUND IR 480.

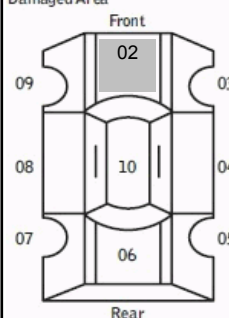
