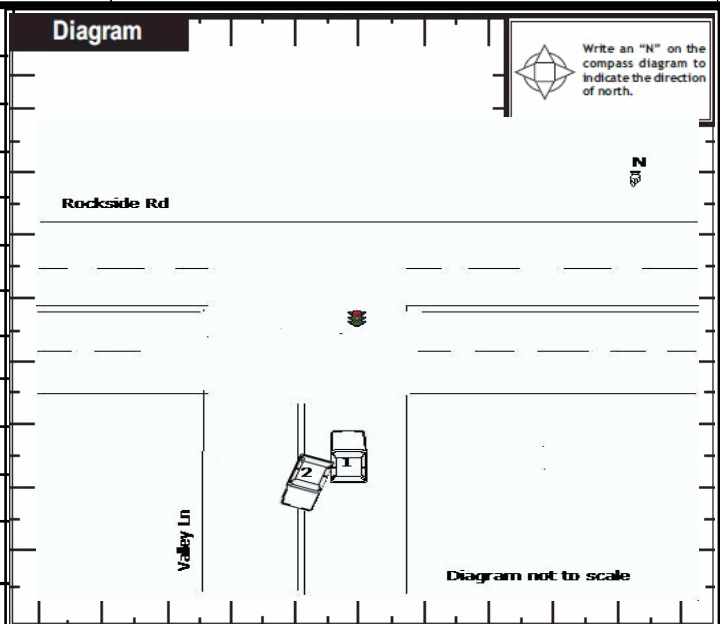

DRIVER OF UNIT 1 STATES HE WAS STOPPED AT THE TRAFFIC LIGHT ON VALLEY LN NEAR ROCKSIDE AND OBSERVED UNIT 2 STOPPED FACING N/B A SHORT DISTANCE FROM HIM. HE STATED THAT AS HE PASSED UNIT 2 PRIOR TO STOPPING AT THE TRAFFIC LIGHT IT APPEARED THAT THE DRIVER AND PASSENGER IN UNIT 2 WERE "PASSED OUT". SUDDENLY THE DRIVER OF UNIT 2 APPEARED TO WAKE UP AND BEGAN REVERSING HIS VEHICLE AND STRUCK THE DRIVER SIDE OF UNIT 1. DRIVER OF UNIT 2 DID NOT RECALL THE EVENTS AND WHEN SPEAKING WITH HIM HE APPEARED TO BE UNDER THE INFLUENCE OF AN UNKNOWN DRUG AND WAS


