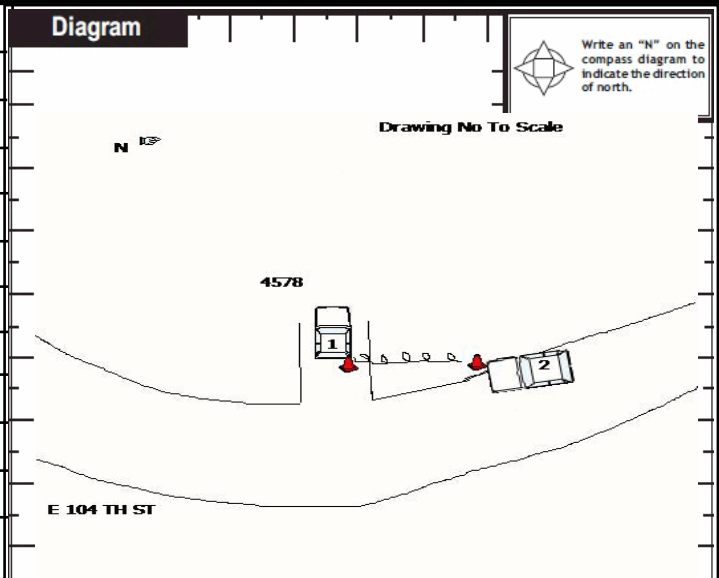

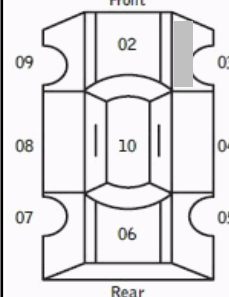

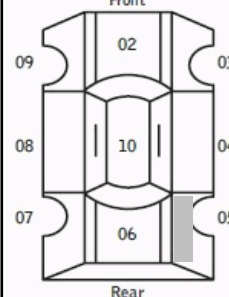
UNIT #1 WAS PARKED IN THE DRIVEWAY LOCATED AT 4578

UNIT #2 LEFT THE ROAD WAY TO THE RIGHT, CAUSING ITS FRONT PASSENGER SIDE FENDER TO MAKE CONTACT WITH A FIRE HYDRANT. UNIT #2 KNOCKED THE FIRE HYDRANT OFF ITS BASE AND INTO THE REAR OF UNIT #1 CAUSING MINOR DAMAGE.
