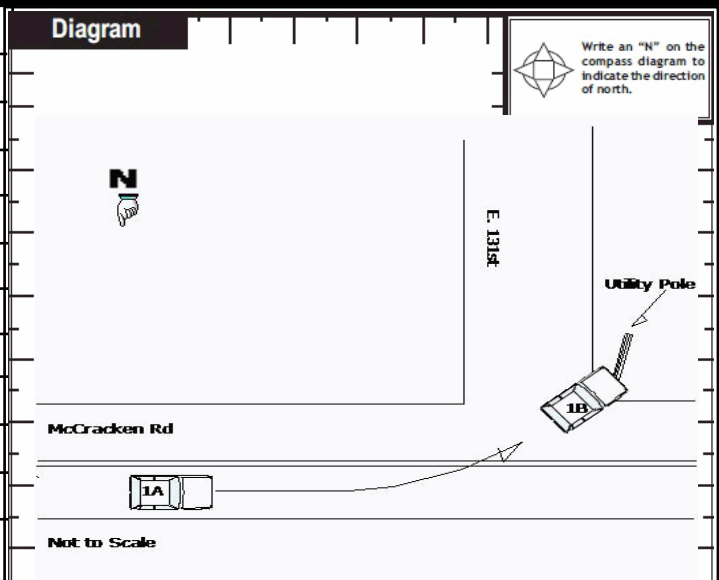

UNIT 1 WAS TRAVELING W/B ON MCCRACKEN RD. TRAILING AN UNKNOWN VEHICLE. UNIT 1 STATES THE VEHICLE QUICKLY SLOWED TO TURN INTO A DRIVEWAY. UNIT 1 SWERVED TO AVOID A REAR END COLLISION, LOST CONTROL AND RAN OVER THE S/W CURB AT E. 131ST. UNIT 1 STRUCK THE UTILITY POLE AT THIS LOCATION CAUSING DAMAGE TO THE POLE AND DISABLING DAMAGE TO VEHICLE.

CEI RESPONDED TO THE SCENE TO REPAIR UTILITY POLE. OFFICERS WERE UNABLE TO LOCATE AN ID NUMBER FOR THE DAMAGED POLE.
