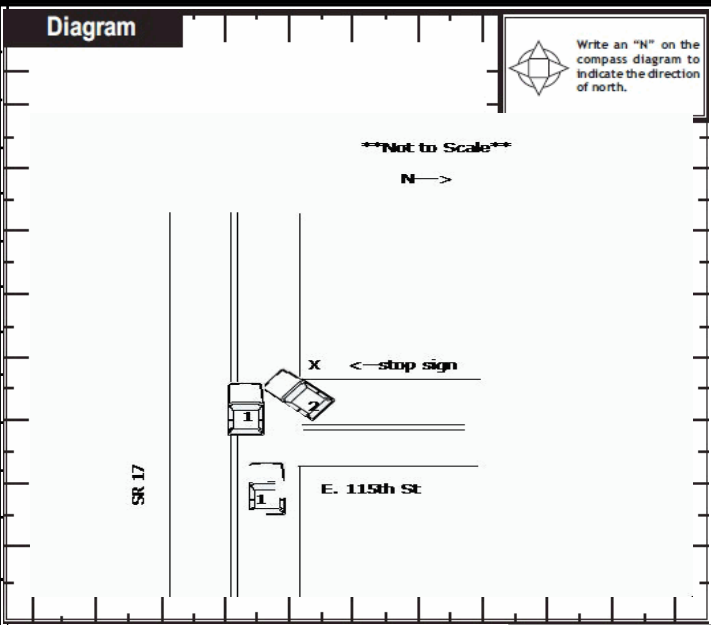

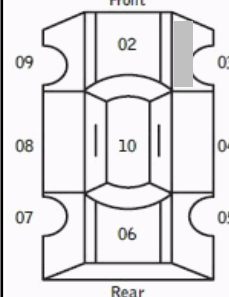

 DRIVER OF UNIT #1 WAS TRAVELLING W/B ON SR 17 NEAR E.115TH STREET IN HEAVY TRAFFIC. DRIVER OF UNIT #2 WAS TRAVELLING ON E.115TH STREET S/B AND APPROACHED THE STOP SIGN AT SR 17. DRIVER OF UNIT #2 LEFT THE STOP SIGN IN ATTEMPTS TO TURN RIGHT(W/B) ONTO SR 17 BEFORE THE TRAFFIC WAS CLEAR. DURING THIS TIME, THE DRIVER OF UNIT #1 SWERVED SLIGHTLY TO THE LEFT TO AVOID BEING STRUCK, BUT WAS STILL HIT BY UNIT #2. ACCORDING TO THE DRIVER OF UNIT #1, THE DRIVER OF UNIT #2 MOVED HER VEHICLE FORWARD AFTER THE CRASH NEXT TO HERS AND SLIGHTLY ON THE TREE LAWN OF 11455 SR 17.
