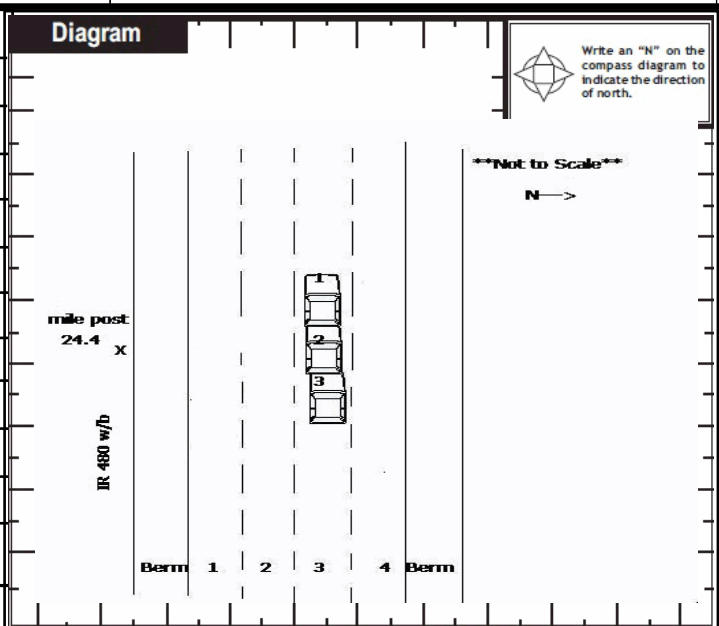



 UNIT #1 WAS STOPPED IN HEAVY TRAFFIC IN LANE #3 ON IR 480 W/B AT MILE POST 24.4. DRIVER OF UNIT #2 WAS STOPPED DIRECTLY BEHIND UNIT #1 IN HEAVY TRAFFIC. DRIVER OF UNIT #3 WAS DIRECTLY BEHIND UNIT #2 IN STOP AND TO TRAFFIC. WHEN TRAFFIC MOVED AHEAD SLOWLY AND CAME TO A STOP, HE WAS UNABLE TO STOP IN TIME. UNIT #3 REAR-ENDED UNIT #2 AND PUSHED UNIT #2 INTO UNIT #1. ALL THREE VEHICLES WERE ABLE TO BE DRIVEN AWAY AFTER THE CRASH.
