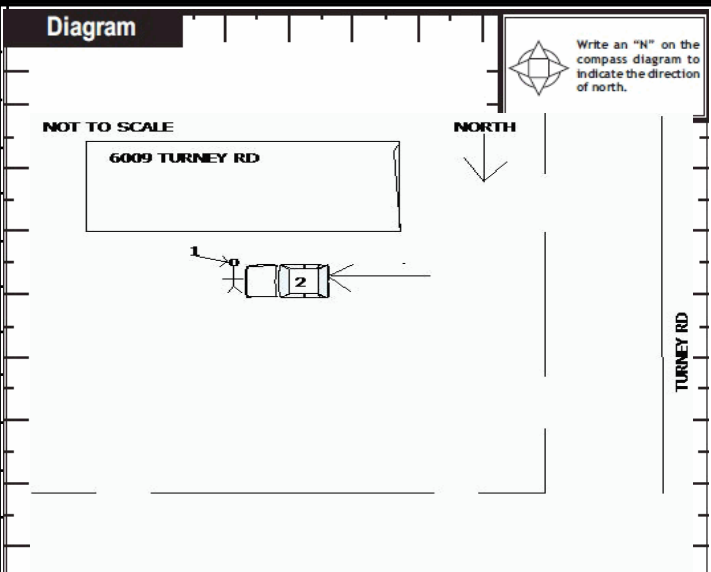

 UNIT 1 (PEDESTRIAN) STATED THAT HE EXITED 6009 TURNEY RD (SUNOCO), STEPPED OF THE CURB AND BEGAN TO WALK ACROSS THE PARKING LOT. UNIT 1 STATED HE OBSERVED A DARK COLORED 2 DOOR PICKUP TRAVELING AT APPROXIMATELY 5-10MPH COMING STRAIGHT AT HIM. UNIT 1 STATED HE PUT HIS ARMS OUT IN FRONT OF HIM AND THE PICKUP TRUCK MADE CONTACT WITH HIS HANDS AND THEN PULLED INTO A GAS PUMP. THE OPERATOR OF THE PICK UP WAS A WHITE MALE, 40-45 Y/O, 5'8-6'0, MED BUILD. UNIT 1 STATED THAT THE OPERATOR OF THE TRUCK DID NOT EXCHANGE ANY INFORMATION OR ACKNOWLEDGE THE ACCIDENT.
