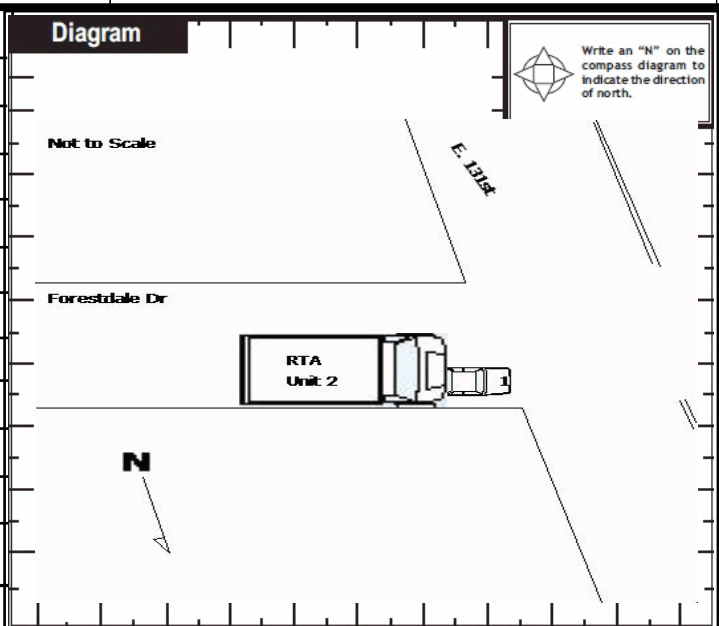

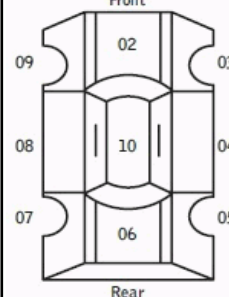
**Narrative**  
 UNIT 1 AND UNIT 2 (RTA BUS) WERE TRAVELING W/B ON FORESTDALE DR. APPROACHING THE INTERSECTION OF E. 131ST. THIS OFFICER OBSERVED VIDEO OF THE ACCIDENT TAKEN BY CAMERAS ATTACHED TO THE UNIT 2. VIDEO SHOWED BOTH UNITS SLOWLY APPROACHING THE INTERSECTION. UNIT 1 BEGAN TO ENTER THE INTERSECTION BUT THEN STOPPED. UNIT 2 STRUCK THE REAR OF UNIT 1. NO DAMAGE WAS OBSERVED TO EITHER UNIT. UNIT 1 DRIVER COMPLAINED OF INJURIES TO HIS NECK AND BACK.
