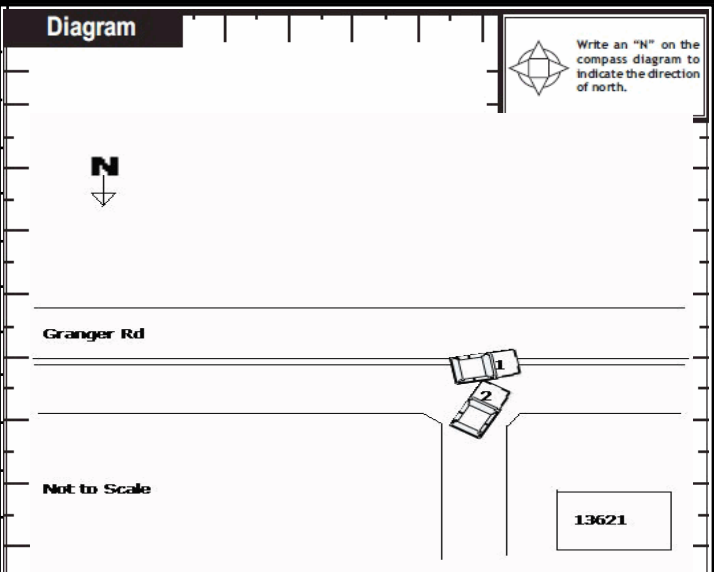

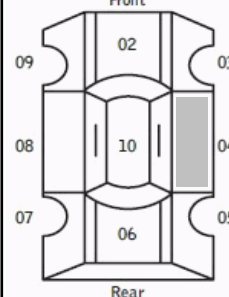


UNIT 1 STATES SHE WAS TRAVELING W/B ON GRANGER RD. AND OBSERVED UNIT 2 BACK INTO THE DRIVEWAY OF 13621 GRANGER RD. UNIT 1 STATES THAT UNIT 2 THEN DROVE FORWARD, BACK INTO THE ROADWAY, FAILING TO YIELD TO TRAFFIC. UNIT STATES SHE ATTEMPTED TO EVADE BY SWERVING TO THE LEFT BUT BOTH UNITS COLLIDED.

UNIT 2 STATES HE WAS BACKING INTO THE DRIVE AT 13621 GRANGER WHEN UNIT 1 ATTEMPTED TO PASS. UNIT 2 STATES AS HE WAS BACKING BOTH UNITS COLLIDED IN A SIDE SWIPE ACCIDENT.
