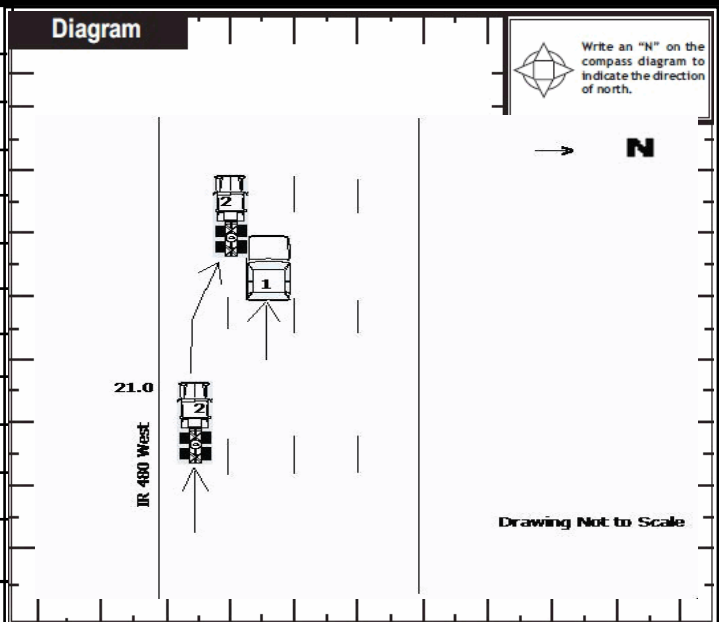



OPERATOR OF UNIT 1 STATED THAT WHILE TRAVELING ON 480W AT TRANSPORTATION BLVD IN LANE 2, UNIT 2 (SEMI TRUCK PA AG08048 TRAILER PLATE PA PT1563Z) WAS TRAVELING IN LANE 1 (FAST LANE) AND BEGAN TO MERGE INTO UNIT 1'S LANE. DURING THE MERGE UNIT 2 STRUCK UNIT 1. UNIT 2 STRUCK UNIT 1 IN THE FRONT LEFT CAUSING DAMAGE TO THE FRONT LEFT, MIRROR, AND SIDE OF THE BOX TRUCK. UNIT 2 STRUCK UNIT 1 WITH THE RIGHT REAR SIDE OF THE TRAILER. UNIT 1 STATED THAT UNIT 2
