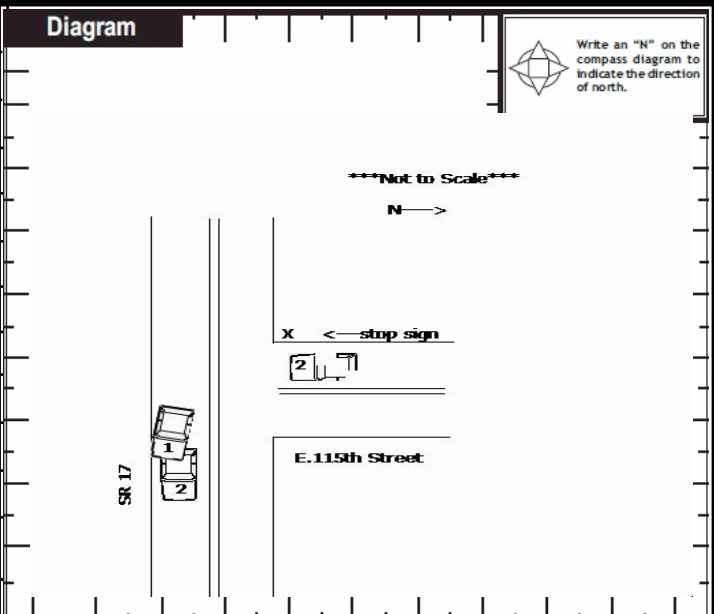



DRIVER OF UNIT #2 STATED SHE PULLED OUT ONTO SR 17, TURNED LEFT TO GO E/B, DIDN'T SEE UNIT #1, AND HER VEHICLE WAS STRUCK. DRIVER OF UNIT #1 STATED SHE WAS DRIVING ON SR 17 WHEN UNIT #2 ENTERED SR 17 AND THERE WAS NO ROOM FOR HER, THUS HER VEHICLE STRUCK UNIT #2. BOTH VEHICLES WERE ABLE TO BE DRIVEN AWAY AFTER THE CRASH.
