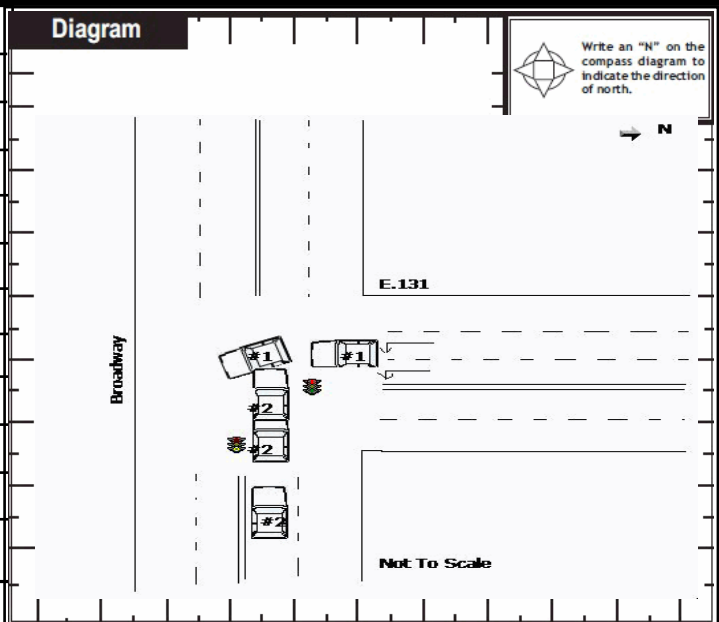


**Narrative**  
 UNIT #1 WAS TRAVELING SOUTH ON E. 131ST AND RAN THE RED LIGHT AT THE INTERSECTION OF BROADWAY AND STRUCK UNIT #2 AS IT WAS TRAVELING WESTBOUND THROUGH THE INTERSECTION. UNIT #2 WAS TRAVELING WESTBOUND ON BROADWAY GOING THROUGH THE INTERSECTION AT E. 131ST AND WAS STRUCK BY UNIT #1 AS IT CAME THROUGH THE LIGHT. UNIT #1 HAD DISABLING DAMAGE ON THE DRIVERS SIDE WITH AIR BAG DEPLOYMENT AND UNIT #2 HAD MINOR DAMAGE ON THE CENTER FRONT OF THE VEHICLE. UNIT #1 WAS TOWED BY A&H
