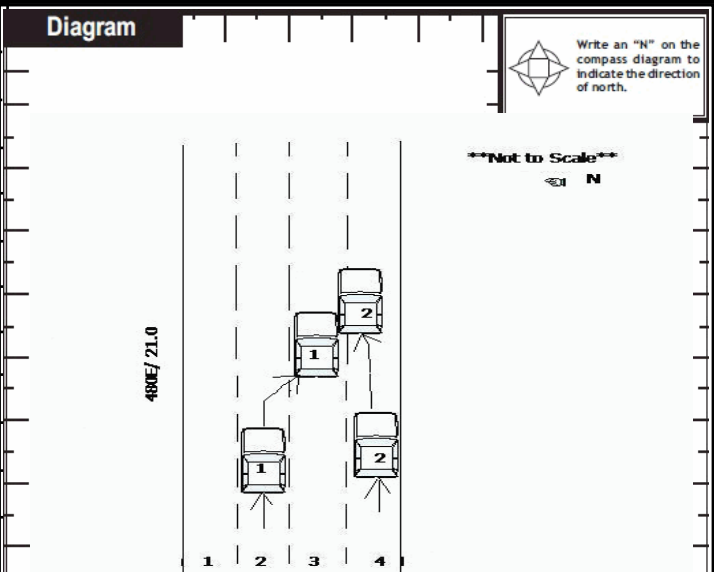

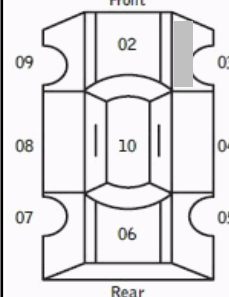
**Narrative**

UNIT 1 WAS TRAVELING ON 480E AT 21.0 IN LANE 2 AND WAS MERGING INTO LANE 3 WHEN UNIT 2 PASSED UNIT 1 ON THE RIGHT USING THE SLOW LANE. UNIT 1 STATED THAT UNIT 2 TRAVELLED AT A HIGH RATE OF SPEED AND ATTEMPTED TO PASS UNIT 1 IN BETWEEN TRAFFIC WHEN UNIT 2 STRUCK UNIT 1 IN THE FRONT RIGHT WITH THE LEFT REAR OF UNIT 2.
