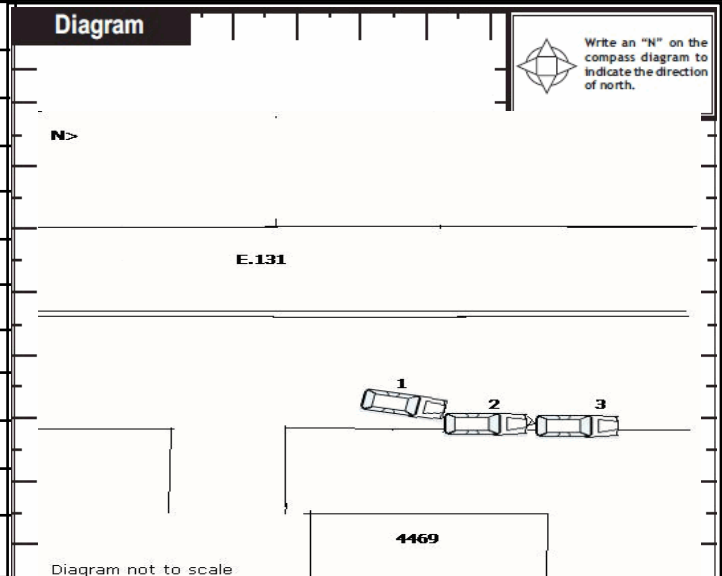

UNIT 1 WAS TRAVELLING NORTH ON E. 131 STREET WHEN AT 4469 E. 131 UNIT 1 LOST CONTROL AND REAR ENDED UNIT 2 ( A PARKED UNIT ON THE RIGHT SIDE OF THE ROADWAY FACING NORTH) THE IMPACT CAUSED UNIT 2 TO COLLIDE WITH UNIT 3 WHICH WAS PARKED DIRECTLY IN FRONT OF UNIT 2. UNIT 1 THEN FLED THE SCENE. UNIT 1 WAS LATER TRACKED DOWN BY A WITNESS TO THE ACCIDENT. THE OPERATOR OF UNIT 1 THEN RETURNED TO THE SCENE WHERE HE WAS ARRESTED FOR DUS AND CITED FOR DUS, HIT SKIP AND FAILURE TO CONTROL.
