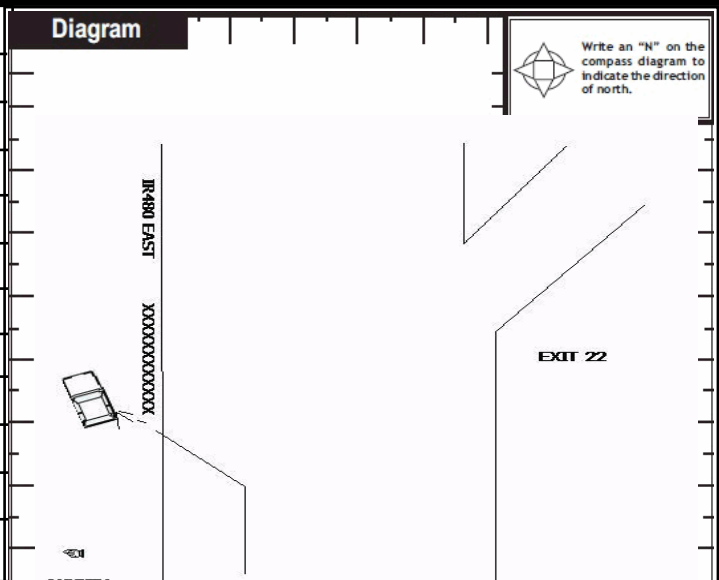

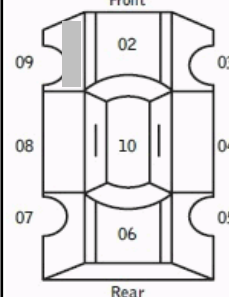
Narrative
