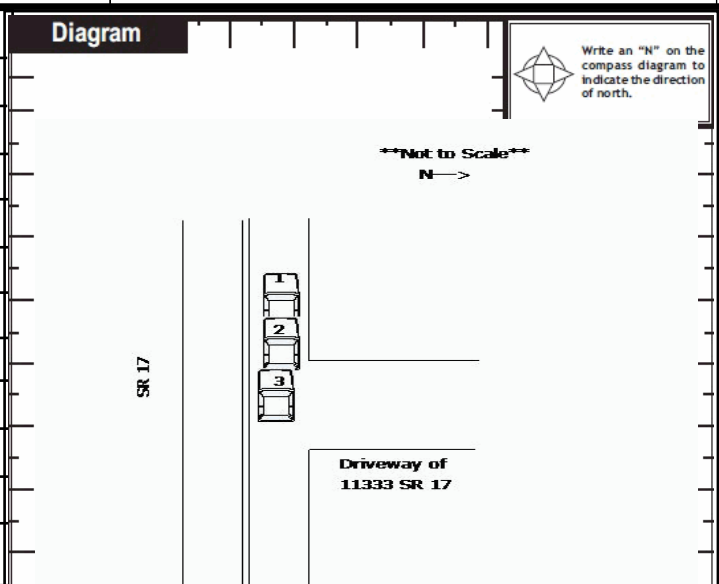

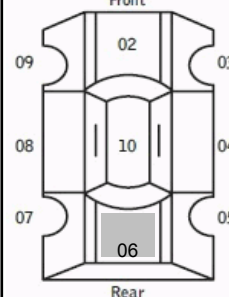



DRIVER OF UNIT #3 STATED HE FOCUSED ON PLACING HIS BEVERAGE IN THE CUP HOLDER AND DIDN'T NOTICE TRAFFIC AHEAD COMING TO A STOP, THUS HIS VEHICLE STRUCK UNIT #2 AND UNIT #2 WAS PUSHED INTO UNIT #1. UNIT #1 HAD VERY MINOR DAMAGE. UNIT #3 HAD TO BE TOWED FROM THE CRASH SCENE.


