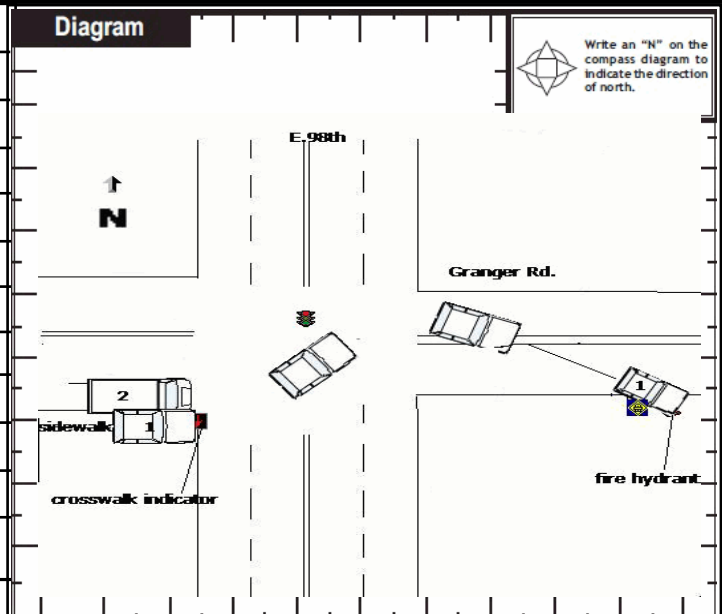

UNIT # 1 WAS EASTBOUND ON GRANGER RD, WHEN IT WENT OFF THE RIGHT SIDE OF THE ROADWAY AND STRUCK SEVERAL HIGHWAY SIGNS AND UNIT # 2 AS IT WAS PARKED FACING EASTBOUND. UNIT # 1 THEN CAME BACK ACROSS TRANSPORTATION BLVD, AS IT OVER CORRECTED IT'S STEERING AND LOST CONTROL, CAUSING IT TO GO OFF THE RIGHT SIDE AGAIN OF GRANGER RD, WHICH IT STRUCK ANOTHER HIGHWAY SIGN AND A FIRE HYDRANT.

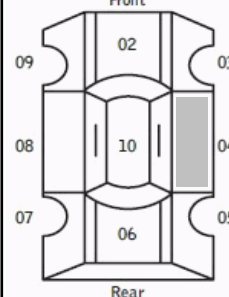


