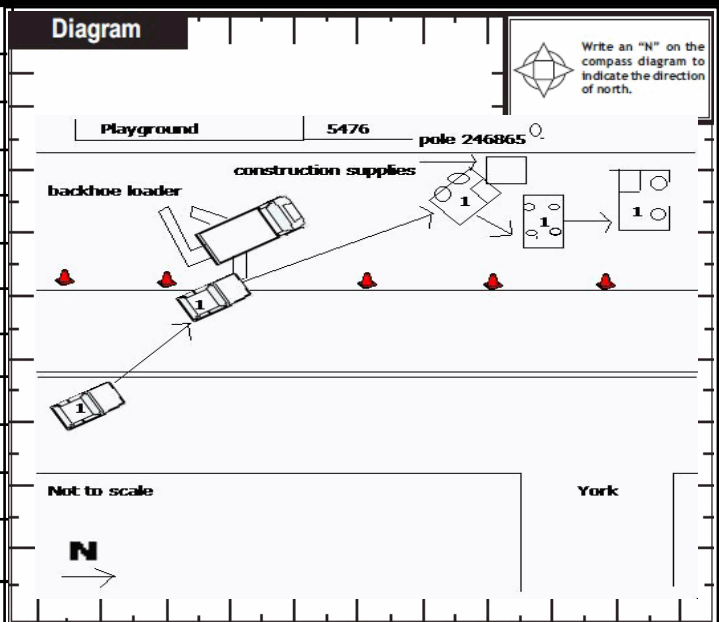

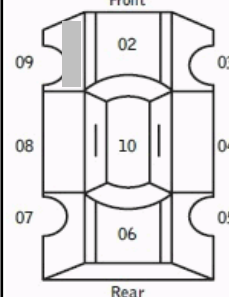

<p>Unit 1 was traveling north on Turney at 5764 and was traveling through a construction zone. The normal south bound lanes on Turney are closed off by barrels and are the active construction area and the normal north bound lanes are split in to one north bound and one south bound for vehicular travel. Unit 1 stated a deer ran in front of him causing him to veer left off the roadway in to the area that was blocked off by barrels. Unit 1 struck the outrigger of a John Deere back hoe Loader that was parked in the construction area with the left front wheel. Unit 1 then flipped on to the passenger side and slid into a pallet of construction supplies that was also sitting in the construction area. Unit 1 then rolled on to its roof and continued rolling on to the drivers side where is came to a rest just north of utility pole # 246865.</p> <p>The back hoe and supplies that were hit belong to the Perk Company. The loader is product identification number 1T0410KXTEE265127. The outrigger appeared to be slightly bent on the top section.
