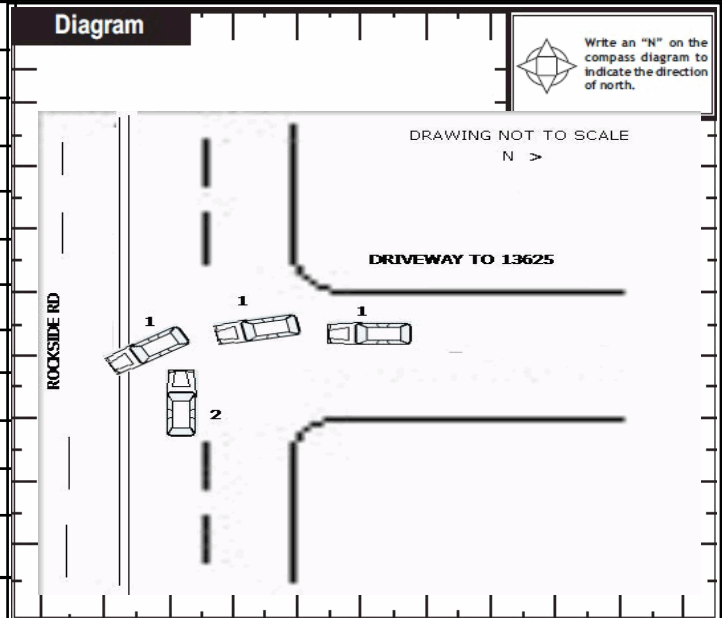

 UNIT 1 WAS TURNING LEFT FROM THE DRIVE OF 13623 ROCKSIDE ONTO EASTBOUND ROCKSIDE RD. UNIT 2 WAS TRAVELLING IN THE CENTER WESTBOUND LANE OF ROCKSIDE RD. UNIT 1 UPON TURNING LEFT, TURNED INTO THE PATH OF UNIT 2 CAUSING UNIT 2 TO STRIKE UNIT 1. THIS SEQUENCE OF EVENTS WAS CORROBORATED BY A THIRD PARTY WITNESS WHO REMAINED ON SCENE.
