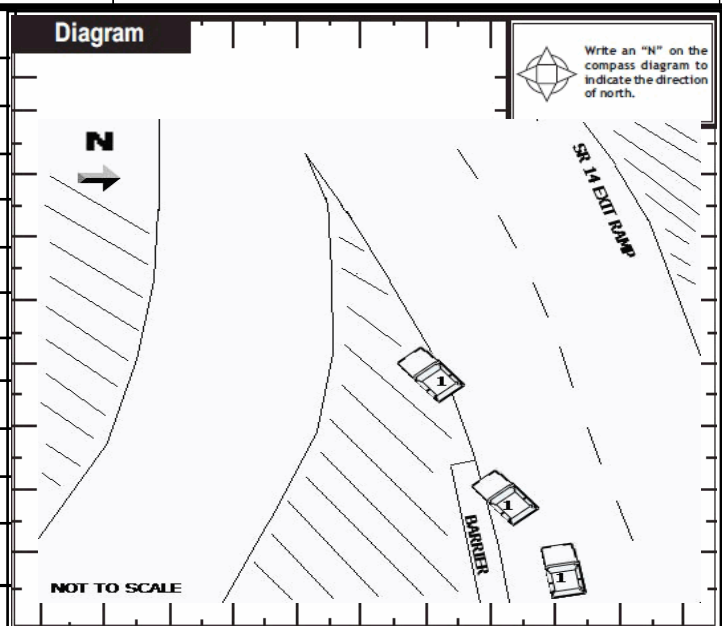

UNIT ONE WAS TRAVELING ON THE SR 14 (BROADWAY AVENUE) EXIT RAMP, FROM IR 480 WEST. WHILE NEGOTIATING A CURVE ON THE RAMP, UNIT ONE'S FRONT, RIGHT TIRE HAD A BLOWOUT. UNIT ONE SUBSEQUENTLY LOST CONTROL, LEFT THE ROADWAY LEFT, AND STRUCK A CEMENT BARRIER IN THE MEDIAN. UNIT ONE THEN CAME TO A COMPLETE REST JUST AFTER THE CEMENT BARRIER ENDED, IN THE GRASS MEDIAN. THE DRIVER OF UNIT ONE COMPLAINED OF MINOR PAIN TO HER ARM. THE FRONT SEAT PASSENGER ALSO SUSTAINED SOME MINOR INJURIES FROM THE AIRBAG DEPLOYMENT. GHFD SQUAD #2 ARRIVED ON SCENE TO
